Proposal for temporary suspension

The statutes of IBCA state the following in point 2.6:

"2.6. Members not fulfilling the duties mentioned in art. 2.4 may be temporarily excluded from IBCA by a decision of the IBCA Congress/Executive Board/Presidential Board and permanently excluded from IBCA by a decision of the IBCA Congress. A member in arrears in the fulfilment of its financial obligations towards IBCA may be temporarily excluded by the Presidential Board, Executive Board or IBCA Congress. This temporary exclusion shall be annulled if the temporarily excluded member has fulfilled its financial obligations 60 days before the IBCA Congress following the temporary exclusion. No participation in any IBCA event or meeting will be permitted during the exclusion period. Payments made after the 60 days but before the IBCA Congress will not allow participation without a majority approval of the IBCA Congress.

The Treasurer shall include information in his report on those Federations that should be temporarily or permanently excluded.

A temporary exclusion made by the Presidential Board or Executive Board shall be submitted to the next IBCA Congress, which will decide on the permanent exclusion of the negligent Federation. This must be an agenda item prior to any election.

In other matters a permanent exclusion can be ruled by the IBCA Congress only if the member is guilty of a severe offence against the statutes, regulations, resolutions or decisions, or acts against the principles of IBCA, taking into account the opinion of the Executive board or Ethics Commission. This must be an agenda item prior to any election."

Hereby the treasurer proposes that federations that have not paid the annual fee for one of the following years: 2021, 2022 or 2023, should be temporarily excluded and are not allowed to vote in the upcoming congress on the 15the of October 2023 if they do not rectify there financial debt to the IBCA.
