AFFIDAVIT OF DIANNA O'BRIEN

IN RE: The application of the Bail Bonds Doctor, Inc.

Dianna O'Brien, being first duly sworn upon oath, states and deposes to the court as follows:


1. I am the president of the Bail Bonds Doctor, Inc. (hereinafter referred to as 'BBDI'), a closely held corporation organized and existing under the laws of the state of Minnesota.
2. BBDI's primary business is the procurement and issuance of surety bonds for bail.
3. On or about February 22, 2021, BBDI posted bail bond 015-10653725 in the amount of 12,000.00.
4. The Defendant had been charged with gross misdemeanor DWI.
5. BBDI notified the Defendant and the cosigner by both email and text messaging of his upcoming court date three days prior to his scheduled court appearance.
6. On September 9, 2021, the defendant failed to appear in court for a hearing in the matter herein, at which time the bond was ordered forfeited by the presiding judge, the Honorable Bev Benson.
7. Immediately upon receipt of the bond forfeiture notice, BBDI began inquiring as to the Defendant's whereabouts. BBDI's agent left messages with the cosigner of the bond indemnity agreement and the Defendant instructing the Defendant to turn himself in to the custody of the Hennepin County Jail. When this effort was unsuccessful, BBDI referred the file to its primary recovery

agent. BBDI's investigator conducted extensive efforts to locate the defendant and made contact with family members and acquaintances of the Defendant. After several interviews and scanning social media outlets, BBDI's agent was able to locate the Defendant, who was living with his parents at a new address, 5710 Upper 179th St. West, Lakeville, MN. On October 22, 2021, BBDI's agent apprehended the Defendant and transferred him, without incident, to the custody of the Hennepin County Jail.

8. The Defendant's warrant was cleared and on October 25, 2021, Mr. Kebede was conditionally released. This constitutes a modified release condition which supersedes the bail bond which is the subject of this affidavit.

9. It should be noted that the Defendant was apprehended and returned to custody solely at the risk and expense of BBDI.


