The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: TRAFFIC-DRIVERS LICENSE-DRIVING AFTER SUSPENSION**

Minnesota Statute: 171.24.1

Maximum Sentence: 0-90 days and/or \$0-\$1,000

Offense Level: Misdemeanor

Offense Date (on or about): 03/09/2020

Control #(ICR#): 20063769

Charge Description: ... operate a motor vehicle, the operation of which requires a driver's license, at a time when his/her driver's license or driving privilege had been suspended by the Commissioner of Public Safety, and defendant had notice of or reasonably should have known of the suspension;

**STATEMENT OF PROBABLE CAUSE**

That on March 9, 2020 at approximately 5:48 p.m. Minneapolis Police Officer Ryan was on routing patrol near 33rd and Colfax Avenue North, in Minneapolis, Hennepin County, Minnesota when a routine license check, 820XLB, returned a hit that it belonged to a stolen vehicle. A stop was initiated, and the driver, identified as Makis Devell Lane, Defendant herein, stated that he did not know the vehicle was stolen because the keys were in the car. Routine checks reveal that Defendant's license was suspended on August 29, 2019 and has not been reinstated as of March 9, 2020. Complainant confirmed that Defendant has not had a valid license in the past decade.
