**COMPLAINT**

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I****Charge: Receiving Stolen Property**

Minnesota Statute: 609.53.1, with reference to: 609.52.3(3)(d)(v)

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 07/21/2021

Control #(ICR#): 21161708

Charge Description: That on or about 7/21/2021, in Hennepin County, Minnesota, MAKIS DEVELL LANE received, possessed, transferred, bought or concealed stolen property or property obtained by robbery, and MAKIS DEVELL LANE knew or had reason to know the property was stolen or obtained by robbery, and the property had a value of less than One Thousand Dollars (\$1,000.00) and the property stolen is a motor vehicle.

**COUNT II****Charge: Carry BB Gun/Rifle/Shotgun/Aslt Wpn-Public Place**

Minnesota Statute: 624.7181.2, with reference to: 624.7181.2

Maximum Sentence: 1 YEAR AND/OR \$3,000

Offense Level: Gross Misdemeanor

Offense Date (on or about): 07/21/2021

Charge Description: That on or about 7/21/2021, in Hennepin County, Minnesota, MAKIS DEVELL LANE carried a BB gun on or about his person in a public place.

**STATEMENT OF PROBABLE CAUSE**

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about July 21, 2021, Minneapolis police responded tip that there was a person with guns in an unlicensed GMC van in the area of Oliver Avenue North and 30th Avenue North, Minneapolis, Hennepin County, Minnesota.

Police went to the area and found the vehicle on the 3500 block of Penn Avenue North, Minneapolis, Hennepin County, Minnesota, and stopped the vehicle. The vehicle did not have any license plates or a temporary license plate on it. The driver of the vehicle was identified as MAKIS DEVELL LANE (DOB 5/18/1988), "DEFENDANT" herein. The vehicle was confirmed stolen by law enforcement.

During a search of the vehicle, law enforcement did find another license plate in the car, but it was for another vehicle. Also, during a search of the vehicle, law enforcement found a BB gun located under the driver's floor mat. The BB gun did appear to be a real gun until closer inspection. The bb gun was even modified to look like a real gun. Another BB gun was found in the rear of the vehicle.

DEFENDANT is currently in custody for this offense.

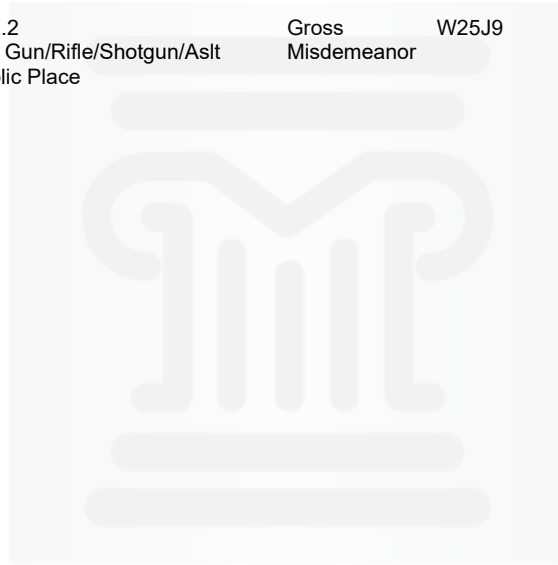
