This matter came before the Court on a request for restitution. The Court has considered the factors set forth in Minnesota Statute § 611A.045, subdivision 1. Based on the files and all proceedings, the Court makes the following findings and order.

1. The defendant must pay restitution.
 - ☒ Restitution of \$692.75 shall be paid as follows:

 - ☒ Restitution shall be paid prior to any other fine, surcharge, or co-pay.
 - ☒ The Court grants any request by the State to make the contact information of victims confidential.
 - ☒ The Court has considered the income, resources, and obligations of the defendant in this order.
2. ☐ This order is final. The defendant agrees to this order and waives any future hearing.
☒ This order is final if the defendant does not file an objection with the court within 30 days.
3. Payment of restitution is due when the order becomes final unless the defendant wants a payment plan.
To qualify for a payment plan, the defendant must provide their social security number to the court.
 - ☐ The defendant must pay at least \$ _____ /month starting 60 days from the final order.
 - ☒ All restitution must be paid no later than 60 days before the end of probation.
4. If payment is not made according to this schedule, or if 60 days pass with no payment being received by the court administrator, the entire amount is immediately due. The matter may be forwarded to the Minnesota Department of Revenue for collection, and a collection fee of up to 25% may be charged.
5. This order may be docketed as a civil judgment by any victim identified above (or their estate) without paying a filing fee.
