**COMPLAINT**

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I****Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 - Not Small Amount Marijuana**

Minnesota Statute: 152.025.2(1), with reference to: 609.101.3, 152.025.4(b)

Maximum Sentence: 5 YEARS AND/OR \$3,000-\$10,000

Offense Level: Felony

Offense Date (on or about): 11/02/2021

Control #(ICR#): 21013860

Charge Description: That on or about 11/2/2021, in Hennepin County, Minnesota, ISAAC LEE KELLEY unlawfully possessed one or more mixtures containing a Schedule I, II, III, or IV controlled substance, to-wit: cocaine.

**COUNT II****Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 - Not Small Amount Marijuana**

Minnesota Statute: 152.025.2(1), with reference to: 609.101.3, 152.025.4(b)

Maximum Sentence: 5 YEARS AND/OR \$3,000-\$10,000

Offense Level: Felony

Charge Description: That on or about 11/2/2021, in Hennepin County, Minnesota, ISAAC LEE KELLEY unlawfully possessed one or more mixtures containing a Schedule I, II, III, or IV controlled substance, to-wit: methamphetamine.

**STATEMENT OF PROBABLE CAUSE**

MAY BE RELEASED AFTER FIRST APPEARANCE IF NO OTHER HOLDS.

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On November 2, 2021, at approximately 8:30 p.m., Minnetonka police officers were dispatched to the Macy's located at 12411 Wayzata Blvd in the City of Minnetonka, County of Hennepin, State of Minnesota, on the report of shoplifting. When they arrived, officers were able to find the suspects exiting the store. Suspects left the store without purchasing merchandise and having passed all points of sale. Officers observed a car pull up and attempt to pick up the suspects. However, before the suspects could enter the car, officers were able to intercept them and place them under arrest.

Officers identified one of the suspects as ISAAC LEE KELLEY, Defendant herein. Defendant was placed under arrest. In a search incident to arrest officers located a pill bottled in Defendant's pants pockets. The two substances in the container were suspected controlled substances. One substance from the container field tested positive as 0.35 grams of cocaine. The other substance field tested positive as 0.14 grams of methamphetamine.

Defendant has prior Chapter 152 convictions in case 85-CR-19-622, 27-CR-13-8682, 62-CR-19-4919.

Defendant is currently in custody.
