

☐ with a police escort to recover personal clothing, prescription medication, and toiletries.

- Do not leave Minnesota unless you have the permission of your Probation Officer and you comply with all the rules of the "receiving state." Your Probation Officer can help you complete the required forms.
- Provide verification of your participation in, and completion of, required services, programs, or evaluations to Probation. Verification allows Probation to confirm your involvement with such services, programs, or evaluations.
- If you are required to register as a predatory offender, your Probation Officer will help you with any required registration; this is, however, always your responsibility. If you are homeless and you are required to register, you must check-in on a weekly basis at a local police station.

Notice: Probation time served out of custody will not count in a future prison term if the stay is revoked.

STANDARD PROBATION CONDITIONS

It is your responsibility to follow all of these conditions of probation and rules of the Hennepin County Department of Community Corrections and Rehabilitation Adult Field Services ("Probation"). You must stay in contact with your Probation Officer. If you have any question about these conditions of your probation or the rules of Probation, contact your Probation Officer. If you do not have the name and number of your Probation Officer, call Probation Intake (612-348-2110) for further instructions.

1. Follow all State and Federal criminal laws.
2. Contact your probation officer as directed.
3. Tell your Probation Officer within 72 hours if you have contact with law enforcement.
4. Tell your Probation Officer within 72 hours if you are charged with any new crime.
5. Tell your Probation Officer within 72 hours if you change your address, employment, or telephone number.
6. Cooperate with the search of your person, residence, vehicle, workplace, property, and things as directed by your probation officer.
7. Sign releases of information as directed.
8. Give a DNA sample when directed.
9. Do not use or possess any firearms, ammunition, or explosives.
10. Do not register to vote or vote until discharged from probation and your civil rights are fully restored.
