The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I****Charge: ASSAULT-4TH DEG-PEACE OFFICER-PHYSICALLY ASSAULTS-G**

Maximum Sentence: 0-1 year and/or \$0-\$3,000

**STATEMENT OF PROBABLE CAUSE**

That on April 2, 2021, at approximately 7:27 p.m., Minneapolis Police Department Officers Erickson and Badowich responded to a report of a fight at 3116 Oliver Avenue North, in the City of Minneapolis, County of Hennepin, State of Minnesota. Remarks in the call were that a female, later identified by MN ID as TEMEKA MICHELLE NICHOLS, had been locked out of the building by other residents. When officers arrived, they spoke to Defendant from their squad car. Officer Erickson was in the passenger seat and Officer Badowich was in the driver's seat with the window down. Defendant approached the driver's side of the squad and told officers she had a warrant for her arrest and needed to call her probation officer. Defendant asked officers to call her probation officer and take her to a different location. Officers denied her request. Defendant responded "Fuck y'all," then reached through the open window and slapped Officer Badowich on the back of the head. Officer Badowich was not injured. During a search incident to arrest, jail staff found a clear glass pipe, commonly used to smoke narcotics, in Defendant's possession.

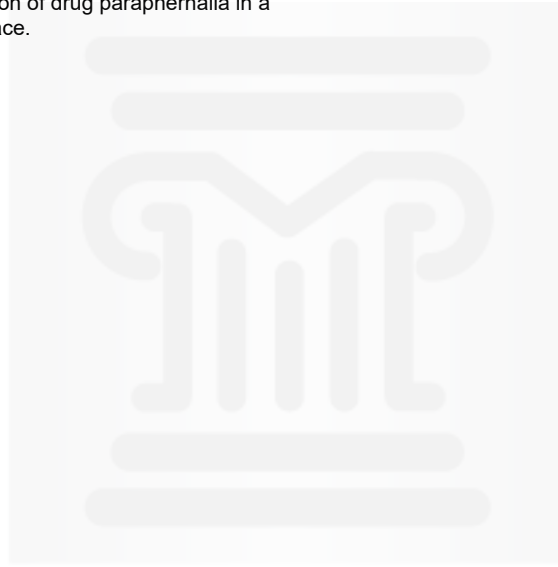
