COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Simple Robbery

Minnesota Statute: 609.24, with reference to: 609.24

Maximum Sentence: 10 YEARS AND/OR \$20,000

Offense Level: Felony

Offense Date (on or about): 04/19/2023

Control #(ICR#): 23096028

Charge Description: That on or about 4/19/2023, in Minneapolis, Hennepin County, Minnesota, Jaleisha Lanay Taylor took personal property from the person or in the presence of Victim, knowing that she was not entitled to the property, and used force against the victim to overcome his resistance or powers of resistance to, or to compel acquiescence in, the taking or carrying away of the property.

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On April 20, 2023, Minneapolis Police Department officers were dispatched to the Walgreens located at 630 Washington Avenue SE in Minneapolis, Hennepin County, Minnesota, for a report of a theft. While en route, the call was updated to an assault.

Upon arrival the reporting party, Victim herein, pointed the suspect out to officers as she emerged from the loading dock area. Officers took the suspect into custody and identified her as Jaleisha Lanay Taylor (DOB 3/18/93), Defendant herein. Officers discovered approximately \$100 worth of items stolen from Walgreen's on Defendant's person.

Victim stated Defendant has been coming into the store approximately four times a week for several months and stealing items. On this particular date, Defendant came in and again started stealing items, so Victim began following her and telling her to leave. Victim stated Defendant refused to leave and started yelling at him. Victim stated that at one point Defendant dropped some items on the floor and he pushed them aside with his foot. He stated Defendant then punched him in the face and left with several items without paying.

Officers also reviewed surveillance video from Walgreens that confirmed Victim's report.

Defendant is in custody.

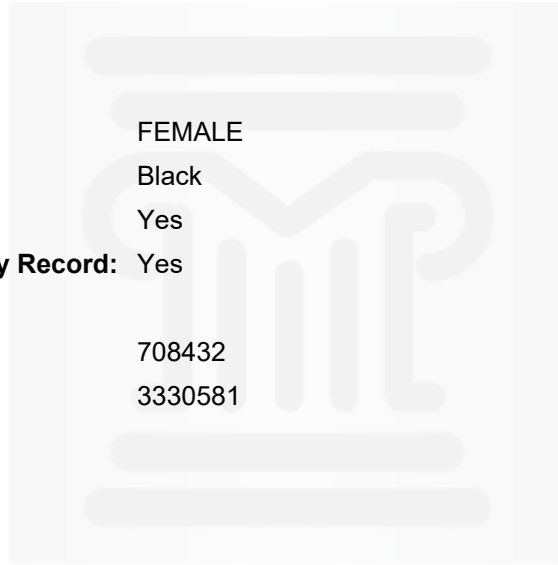
