**COMPLAINT**

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I****Charge: Simple Robbery**

Minnesota Statute: 609.24, with reference to: 609.24

Maximum Sentence: 10 YEARS AND/OR \$20,000

Offense Level: Felony

Offense Date (on or about): 05/05/2023

Control #(ICR#): 23015878

Charge Description: That on or about 5/5/2023, in the area of 7600 Brooklyn Blvd in Brooklyn Park in Hennepin County, Minnesota, TIMOTHY TERRELL STUCKEY took personal property, from the person or in the presence of victim, knowing that he was not entitled to the property and used and/or threatened the imminent use of force against the victim to overcome his resistance or powers of resistance to or to compel acquiescence in the taking or carrying away of the property.

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On 5/5/2023 at approximately 16:00 hours, officers were dispatched to the area of 7600 Brooklyn Blvd in Brooklyn Park, Hennepin County for a theft from person. Callers indicated that an elderly male with a cane had been pushed over and money taken from him.

Upon arrival, officers were flagged down by witnesses in the area of 8100 Zane Ave N. Two females reported they saw the suspect, identified as TIMOTHY TERRELL STUCKEY, DOB: 11/27/1978, (now referred to as DEFENDANT), snatch paper money from the hand of the victim and saw him yelling for help. The witnesses followed DEFENDANT until police arrived.

The victim spoke with officers and told them he lives in a group home nearby and frequents the area. The victim sat down on the curb in front of the Dollar Tree store and was counting money he had when DEFENDANT pulled two \$20 bills from his hand and ran away. Victim uses a cane and had a cast on his foot, so he was not able to chase him and yelled for help.

DEFENDANT was taken into custody and read his Miranda rights. DEFENDANT said victim gave him \$20 to buy him marijuana. One - \$20 bill was located on DEFENDANT.

DEFENDANT is currently in custody at the Hennepin County Jail.

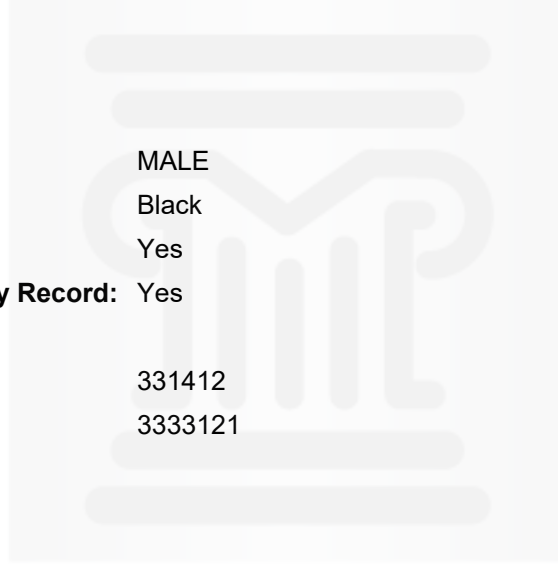
