This correspondence is in regards to the Evaluation Report I received on 12/4/2023 from my court hearing with Judge Kerry Meyer from Dr. Boland's Office, Psychological Disorder Services, C-509, 300 South Sixth Street, A-600 Government Center, Minneapolis, MN 55487. Due to circumstances out of my control from 12/21/2023 to 1/10/2024, I did not file my objections to this Evaluation Report timely and in accordance with MN Rule 20.06 sub 5 Competency Determination within 10 days upon receipt of the Evaluation Report. However, this correspondence contains my objections to that Evaluation Report.

I, Anne Riley, object to the inaccurate content within my Evaluation Report from Dr. Boland's Office, as this Evaluation Report is inaccurate and does not line up with my diagnosis from a psychological healthcare professional, whom has been treating my disability through their office of practitioners since Year 2002. I advise less relevance on Dr. Boland's Evaluation Report as this evaluation covered office time of one and one-half hours resulting in inaccurate data and information presented to the MN Court System. Whereas, the practitioner's whom have been treating my disability since Year 2002 and issued a separate report when I utilized my former employer's disability policy employment benefit that more accurately reflects a diagnosis for my disability. Therefore I object to the validity of the contents of Dr. Boland's Evaluation Report and the inaccuracy of data and information presented in that Evaluation Report.

Furthermore, under MN Statute 273.13, I understand that my property 3847 Orchard Ave. N., Robbinsdale, MN 55422, my Homestead, my Eminent Domain is class 1b, which means I am covered under ADA law. Could you offer assistance as I seek assistance from the MN Attorney General?

Office so that I, Anne Riley, am not unlawfully detained from gaining lawful entrance to my Homestead, 3847 Orchard ave. n. Robbinsdale, MN 55422? Furthermore, I, Anne Riley, am seeking restoration of my property ownership rights through Hennepin County Resident and Real Estate Services (HCRRE) and the MN Dept of Revenue (DOR) through a State Repurchase Deed and/or Auditor's receipt as indicated in the Delinquent Tax and Tax Forfeiture Manual and a written recording in the Hennepin County Records Log to reestablish myself, Anne Riley, as the property owner of 3847 Orchard ave. n. Robbinsdale, MN 55422.

I, Anne Riley, am the daughter of Margaret and James Riley, Sr who became the property owners of 3847 Orchard ave. n. Robbinsdale, MN 55422 in Year 1967. Then, I, Anne Riley, became the property owner of 3847 Orchard ave. n. Robbinsdale, MN 55422 in Year 1999 through a related-party mortgage loan between my parents and myself, Anne Riley, financed through a mortgage company. I, Anne Riley, paid off that mortgage loan in Year 2014. I, Anne Riley, must return to, live and reside, alone, in and at my own property, 3847 Orchard ave. n. Robbinsdale, MN 55422, my Homestead, my Eminent Domain. Furthermore, there are unresolved issues, as noted above, pertaining to my property ownership rights to my own property, 3847 Orchard ave. n. Robbinsdale, MN 55422, property taxes going forward to prevent fraudulent activity and Public Law 106-185 (2400X) since the USA is liable for a wrongful tax forfeiture of my property, 3847 Orchard ave. n. Robbinsdale, MN 55422 and reimbursement for expenses during this wrongful tax forfeiture through a negotiable check issued payable to myself, Anne Riley, 3847 Orchard ave. n. Robbinsdale, MN 55422 with adequate funds backing the negotiable check and without placing debt in/on my Caucasian female adult human body. I, Anne Riley, would not have incurred these expenses if this tax forfeiture had not occurred.
