The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Drugs - 3rd Degree - Possess 10 grams or more a narcotic drug other than heroin**

Minnesota Statute: 152.023.2(a)(1), with reference to: 609.101.3, 152.023.3(a)

Maximum Sentence: 20 YEARS AND/OR \$75,000-\$250,000

Offense Level: Felony

Offense Date (on or about): 05/28/2019

Control #(ICR#): 19151137

Charge Description: That on or about 5/28/2019, in Hennepin County, Minnesota, TERRELL JOHNSON unlawfully possessed one or more mixtures of a total weight of 10 grams or more containing a narcotic drug other than heroin, to-wit: methamphetamine.

**STATEMENT OF PROBABLE CAUSE**

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

That on May 28, 2019, officers with the Minneapolis Police Department responded to an unwanted person report at a bank located at 2700 Hennepin Avenue South, Minneapolis, Hennepin County, Minnesota. Upon arrival at the bank, officers learned that security guards and the bank manager had asked an individual to leave several times because the individual had no business to conduct there, but the individual refused. Officers identified the individual who refused to leave, later identified as TERRELL JOHNSON, AKA TERRELL DANNIE JOHNSON, DEFENDANT herein, and informed DEFENDANT that he was trespassing and had to leave. DEFENDANT refused to leave. The bank manager told DEFENDANT again that DEFENDANT had to leave, and DEFENDANT again refused. Officers arrested DEFENDANT and during a search incident to arrest, officers recovered a methamphetamine pipe and two baggies each containing 9.1 grams of field tested positive methamphetamine, weighed without packaging. The total methamphetamine recovered was 18.2 grams.

DEFENDANT is currently in custody.


