**COMPLAINT**

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I****Charge: Aggravated Robbery-1st Degree**

Minnesota Statute: 609.245.1, with reference to: 609.245.1, 609.11.4

Maximum Sentence: 20 YEARS AND/OR \$35,000

Offense Level: Felony

Offense Date (on or about): 01/15/2021

Control #(ICR#): 21010532

Charge Description: That on or about January 15, 2021, Minneapolis, Minnesota, in Hennepin County, Minnesota, IBSSA M. YOUSSEF, in the presence of Victim, knowing that he was not entitled to the property and used and/or threatened the imminent use of force against Victim to overcome her resistance or powers of resistance to or to compel acquiescence in the taking or carrying away of the property, and inflicted bodily harm upon Victim, while using a dangerous weapon.

Minimum Sentence: 1 YEAR AND 1 DAY

**COUNT II****Charge: Assault-2nd Degree-Dangerous Weapon-Substantial Bodily Harm**

Minnesota Statute: 609.222.2, with reference to: 609.222.2, 609.11.4, 609.101.2

Maximum Sentence: 10 YEARS AND/OR \$6,000-\$20,000

Offense Level: Felony

Offense Date (on or about): 01/15/2021

Control #(ICR#): 21010532

Charge Description: That on or about January 15, 2021, Minneapolis, Minnesota, in Hennepin County, IBSSA M. YOUSSEF, assaulted Victim and inflicted substantial bodily harm, while using a dangerous weapon.

Minimum Sentence: 1 YEAR AND 1 DAY

**STATEMENT OF PROBABLE CAUSE**

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On January 15, 2021, Minneapolis Police Department officers responded to possible stabbing on East Franklin Avenue, Minneapolis, Minnesota in Hennepin County.

Law enforcement spoke with Victim, who identified the suspect as mixed-race male, small and wore a black jacket and black pants.

Victim said she was leaving the store with grocery bags in her hands, walking to the back-parking lot. At that point, the suspect approached her and asked for money. The suspect took out a silver knife from his pants pocket. Victim said "no," and "stop." The suspect stabbed her in the side of her left thigh. Victim put up her left hand to protect herself; suspect slashed the web of her hand between her thumb and index finger.

The suspect also stabbed Victim in the back by her right shoulder. (The knife was later retrieved by law enforcement.) Victim did not have any weapons and did not defend herself other than putting up her left hand after she was stabbed.

Other officers arrived on scene; they were told Victim was on the Chicago Avenue South side of the building. A man was standing just outside of the door; he did not appear to have any injuries. Officers spoke with the man, later identified as IBSSA MOHAMED YOUSSEF (date of birth, 09/22/1983, Defendant). Officers asked him if he was hurt. Defendant said, "I stabbed her." Defendant also fit the description of the suspect.

Defendant said he had surgery weeks ago and was attacked in the neck. He said they jumped him and stole his phone, so he stabbed her.

As of this writing, Defendant is in custody.

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
