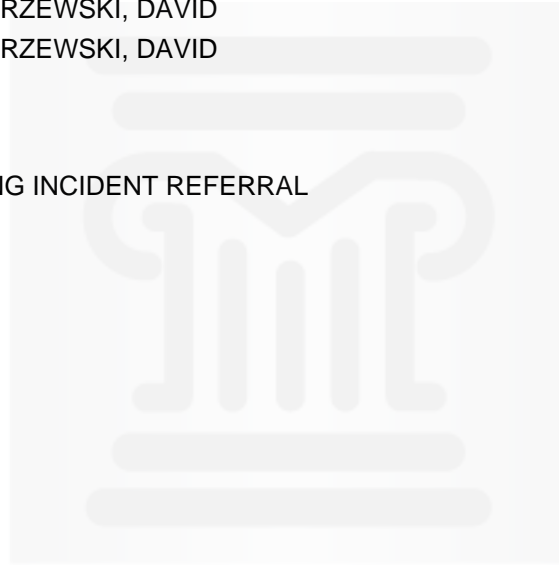

On 01-15-21, I was working Car 710 with Sgt. Vanessa Anderson when we were notified about a stabbing at 1519 E. Franklin Ave. and the Victim1/FARDOSA KULMIYE not non-life-threatening stab wounds and was transported to Hennepin Healthcare Hospital (HCMC) by ambulance. I was already to HCMC and met officers who arrived with V1. I was briefed by officers that V1 was shopping inside the store at 1519 E. Franklin Ave. and when she left the store she was confronted by the suspect who demanded money and pulled out a knife and stabbed her multiple times.

I contacted the MPD Strategic Information Center (SIC) and asked them to check the Milestone camera at Bloomington Ave. and E. Franklin Ave. for any video of the incident. I was told video was saved and added to Evidence.com.

Officers arrived at HCMC with Suspect2/IBSSA YOUSSEF and I was told by officers they found him at 1800 Chicago Ave. S. CCN# 21-010601. Officers stated S2 voluntarily told them he was in the back parking lot of a store by Bloomington Ave. S. and E. Franklin Ave. when someone tried to grab or stab him and S2 stabbed a person. Officers reported S2 was at HCMC to be evaluated for possible hypothermia.

I met with V1 at HCMC ER and interviewed her about the incident. The interview was audio recorded and uploaded to the Milestone system. The following is a summary of the interview. I asked V1 to physically describe the suspect who attacked her. V1 reported Suspect1 was a mixed race male possibly white and black and he was "small", wore a black jacket and black pants. V1 stated she thought S1 was 30 to 40 yo. and had black hair. V1 said S1 was a little shorter than her and she is 5'8" tall. V1 explained she was not able to give a better description of S1 because the incident happened so fast and she didn't think she could recognize S1 if she saw a picture of him.

V1 recalled she was leaving the store with grocery bags in her hands and walking in the back parking lot when S1 approached her and asked for money. V1 stated S1 took out a silver colored knife from his pants pocket and she told him "No" and "Stop" and S1 stabbed her in the side of her left thigh. V1 remembered she put up her left hand to protect herself and S1 slashed the web of her hand between her thumb and index finger. I noticed an approx. 3" red scratch on her left hand. V1 also reported S1 stabbed her in the back by her right shoulder. V1 denied having any weapons or defending herself except for putting up her left hand to protect herself after she was stabbed in the leg. V1 stated she didn't think S1 took any of her property. V1 explained she didn't have a purse or wallet with her and her cell phone was in her pant's pocket. V1 did say she dropped her bags of groceries in the parking lot during the attack.

V1 signed a medical release form so a copy of her medical record could be added to the case.

On January 15, 2021 I was working car 710 with my Partner Sgt. Willner. I was notified by Sgt. Porras that there was a stabbing in the 3rd precinct at 1519 Franklin Ave E in the rear parking lot. I was told there may be witnesses on scene and the suspect's vehicle so I responded to the scene.

When I arrived, I did not observe any blood in the parking lot, although the parking lot and dark and the pavement was wet at the time. After speaking with my partner who spoke with the victim, I was told the suspect may have come inside the store and then ran out the front of the store. Later we found out this was a miscommunication. However, I spoke with the employee, Abdalla Issa 612-229-6322, who brought the victim inside the rear of the store and let her lay down after she had been stabbed. It appeared there was a small amount of a blood like substance where she was laying. It should be noted there are cameras inside the store, that should have been recording but only the owner would have access those cameras.

I then went to the tobacco shop next door and spoke with the employee about getting access to the cameras in the rear of store that faced the parking lot. The contact person for the cameras at 1513 E Franklin Ave is ABDI ALI 612-481-2048. Neither of the employees that I spoke with were able to get a detailed identification of the suspect.

I was notified that there was another call at 1800 Chicago where someone reported that they had just stabbed someone. I responded to that location and the suspect was with EMS. It was suggested he be transported to HCMC to receive medical care for an unknown medical condition at this time due to a language barrier.

SICM was able to send a picture of the suspect from Franklin Ave/ Bloomington cameras, the picture was forwarded to me from Sgt. Porras. The suspect appeared to be wearing white shoes, dark clothing, and something white around his neck. The person at 1800 Chicago was wearing similar clothing.

The suspect was transported to HCMC to receive medical care and then was to be booked PC Agg. Robbery.

My BWC was activated and uploaded to evidence.com. It was activated and deactivated throughout the call to make phone calls and have private conversations with officers.

On 01/15/2021 I was working squad 312 with Officer Jonathan Patino. At approximately 1950 hours, we responded to a stabbing call at 1519 Franklin Ave E (Franklin Deli). Remarks stated that a female had been stabbed. The caller was attempting to have the witnesses stay at the scene.

Upon arrival, we had a male guide us toward the victim who was inside of the address. We saw this male in the rear parking lot along with a large group of people. We made entry through the back of the store. I saw the victim laying on the floor on her side near the back of the store. The victim, later identified as Fardosa Kulmiye using DVS, told me that she had been stabbed on her left thigh and on her shoulder. I saw blood on her dress right over her left thigh and over her shoulder. I checked the injuries and saw lacerations on both her left thigh and shoulder. I could see she was in a lot of pain because she was crying hysterically. EMS arrived to the scene and quickly transported Fardosa to the hospital. I rode in the ambulance with Fardosa and asked her what happened. She informed me of the following information.

Fardosa arrived to the address in her maroon Chevrolet Equinox. Fardosa parked her vehicle in the rear of the address and went inside to buy groceries. Once Fardosa was done, she walked out of the address and back into the rear parking lot. Fardosa was carrying her grocery bags and walking through the parking lot back to her vehicle. As she was walking back to her vehicle, the unknown suspect approached Fardosa and got in front of her. Fardosa tried to go around the unknown suspect but he began to demand for money. The unknown suspect did not display a weapon at this time and was only asking Fardosa for money. Fardosa tried to walk around the unknown suspect again and he blocked her path. Fardosa told the unknown suspect "hey, stop!".

When she told this to the unknown suspect, he pulled out a knife from his pant pocket and began lunging at her with the knife. She yelled "stop" again but the unknown suspect stabbed her on her left thigh. Fardosa also received a very small laceration on her left hand when she was trying to defend herself. Fardosa fell to the ground and dropped her groceries as well. Fardosa told me that she was able to get up and began to scream for help. Fardosa began to run away from the unknown suspect. As she was getting up, the unknown suspect stabbed Fardosa on her shoulder as well. Fardosa made it to the rear entrance of the address. A male was standing by the entrance or exiting the address and chased after the unknown suspect. Before going inside, Fardosa told me that she saw this male take the knife away from the unknown suspect before chasing him on foot.

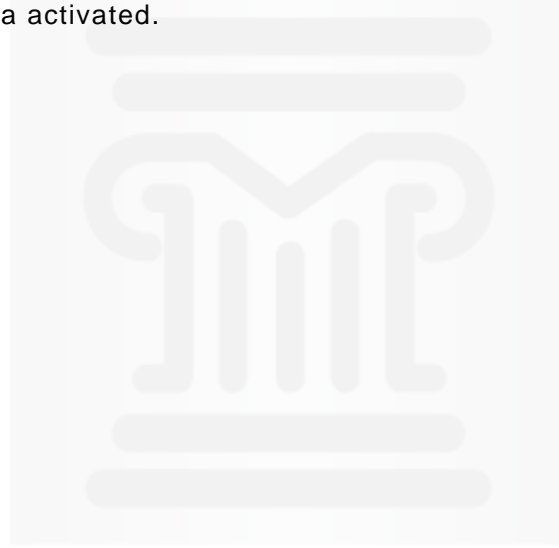
Fardosa described the unknown suspect as a mixed black and white male, between the age of 30-40 years old, short height, black short hair, and wearing a black jacket and face mask.

During the above dates and times while working with my partner Officer Perry, officers were dispatched to the report of a stabbing call at 1800 Chicago Ave S. The remarks of the call indicated that security at the building was aware of the incident but not with the victim. The remarks also gave a description of the victim and that he had apparently been stabbed in the back.

Upon arriving on scene officers were shown by security to where the victim was on the Chicago Ave S. side of the building. The male was standing just out side of a door and officers did not immediately note any injury. Officers spoke with the male (YOUSSUF) who spoke in broken English asking him where he was hurt, Officers located no wounds on Youssuf. Youssuf made comments that "I stabbed her" to officers as we spoke with him. As officers were looking for wny wounds a knife was located and passed off to another officer. It became apparent that due to Youssuf's comments and the fact that he fit the description of a suspect in an earlier stabbing that he may be the suspect from that event. Squad 302 arrived on scene and this information was passed on to him.

EMS arrived and I notified the paramedics that Youssuf was wet and that we had not found any wounds on him. I asked if he could be checked by them in the ambulance to ensure that he was not hurt.
