**COMPLAINT**

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I****Charge: Burglary-3rd Deg-Steal/Commit Felony or Gross Misd**

Minnesota Statute: 609.582.3, with reference to: 609.582.3

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 10/21/2021

Charge Description: That on or about 10/21/2021, in Hennepin County, Minnesota, BRITTANY LATESHA CRUTCHFIELD, either directly or as an accomplice, entered a building without consent and with intent to steal or commit any felony or gross misdemeanor while in the building, or entered a building without consent and stole or committed a felony or gross misdemeanor while in the building.

**COUNT II****Charge: Fleeing a Peace Officer By a Means Other Than a Motor Vehicle**

Minnesota Statute: 609.487.6, with reference to: 609.487.6

Maximum Sentence: 90 DAYS AND/OR \$1,000

Offense Level: Misdemeanor

Offense Date (on or about): 10/21/2021

Charge Description: On or about 10/21/2021 in Hennepin County, Minnesota BRITTANY LATESHA CRUTCHFIELD for the purpose of avoiding arrest, detention, or investigation, or in order to conceal or destroy potential evidence related to the commission of a crime, attempted to evade a peace officer by running, hiding, or other means not including fleeing in a motor vehicle.

**STATEMENT OF PROBABLE CAUSE**

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On October 21, 2021, at approximately 12:16 pm, officers responded to Walgreens located at 627 Broadway, Minneapolis, Hennepin County, Minnesota for a theft. Caller remarks provided a description of the suspect, and stated the suspect was known to Walgreens staff and has been formerly trespassed.

Upon arrival, officers located the suspect, identified as BRITTANY LATESHA CRUTCHFIELD, AKA BRITTANY LATESHIA CRUTCHFIELD (DOB: 3/6/1988), Defendant herein, who was walking nearby with a large tote bag of items. As officers attempted to make contact with her, she dropped her tote bag and began running away from officers. Officers eventually apprehended the Defendant and recovered the stolen merchandise. The total amount of stolen items was \$74.96.

Officers spoke with T.L., the manager at Walgreens, and learned the Defendant was immediately recognized upon entering for prior shoplifting incidents. The Defendant had been previously trespassed from Walgreens on multiple occasions.

The Defendant is currently in custody and has multiple open theft and trespass cases pending.

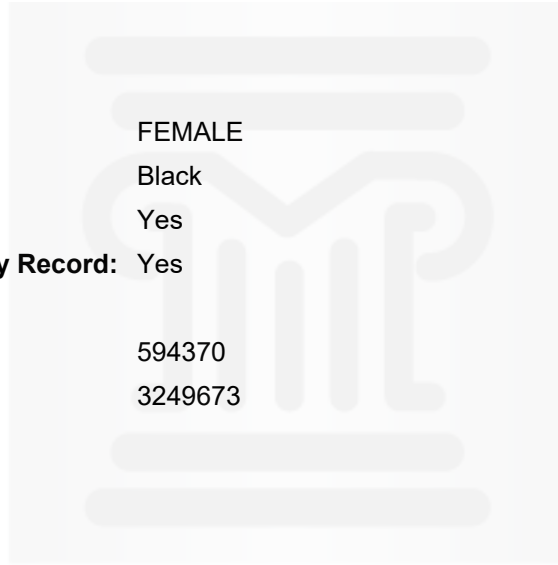

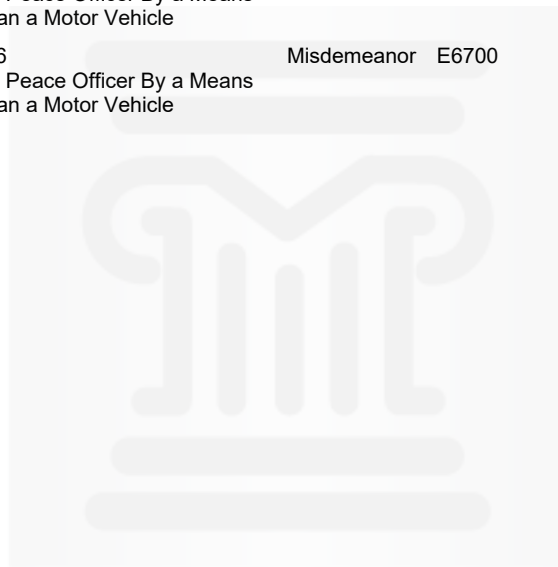
