**COMPLAINT**

Warrant

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Burglary-3rd Deg-Steal/Commit Felony or Gross Misd**

Minnesota Statute: 609.582.3, with reference to: 609.582.3

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 11/09/2021

Control #(ICR#): 21258730

Charge Description: That on or about 11/9/2021, in Minneapolis in Hennepin County, Minnesota, Gordon Eugene Sharp Jr, either directly or as an accomplice, entered a building without consent and with intent to steal or commit any felony or gross misdemeanor while in the building, or entered a building without consent and stole or committed a felony or gross misdemeanor while in the building.

**STATEMENT OF PROBABLE CAUSE**

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On November 9, 2021, officers responded to the TARGET located at 1300 Lake St. W. in Minneapolis, Hennepin County, for a known shoplifter who had been trespassed on August 18, 2021, and October 26, 2021, and has a long history of stealing from the store. As officers arrived, they observed the Defendant walk away from a cart full of merchandise he had and walked towards another exit that he used. Officers pursued the Defendant and stopped him after he exited the store and recovered stolen property from him including three pairs of Skullcandy headphones, two pairs of InMotion sunglasses, and a pair of scissors.

The Defendant was arrested and during booking, officers located suspected methamphetamine that is pending testing. The Defendant is charged with burglary third degree, from the same store for an October 1, 2021, incident, in MINCIS file 27CR2120072. The store has documented Defendant's involvement with 46 thefts in the store between June 15, 2021 and October 9, 2021.

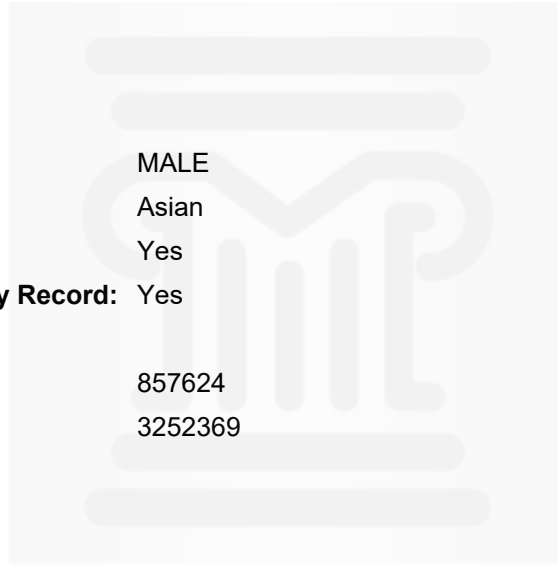
