The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Burglary-3rd Deg-Steal/Commit Felony or Gross Misd

Minnesota Statute: 609.582.3, with reference to: 609.582.3

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 11/16/2021

Charge Description: That on or about 11/16/2021, in Hennepin County, Minnesota, Gordon Eugene Sharp Jr, either directly or as an accomplice, entered a building without consent and with intent to steal or commit any felony or gross misdemeanor while in the building, or entered a building without consent and stole or committed a felony or gross misdemeanor while in the building.



STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On November 16, 2021, officers responded to a theft in progress at Target located at 1300 W Lake St., Minneapolis, Hennepin County, Minnesota. The suspect was known to Loss Prevention employees as GORDON EUGENE SHARP JR. (DOB: 5/13/1988), Defendant herein, and a physical description and direction of travel were provided to responding officers.

Upon arrival, officers located the Defendant pushing a Target shopping cart full of merchandise and wearing the clothing described. The Defendant was detained, and A.A., a Target Loss Prevention employee, positively identified the Defendant as the shoplifter. The Defendant was taken into custody and found to have active warrants. The total loss from this incident was \$257.61.

Loss Prevention reported the Defendant had been previously trespassed from Target in August 2021. Officers received the Trespass Notice that had been given to the Defendant on August 18, 2021.

Loss Prevention further reported that the Defendant had also been in Target earlier on the same day and took ties, as well as having committed other thefts earlier in the week. Target identified the Defendant as having stolen merchandise from the store on November 11th, 15th, and twice on the 16th. The total loss is estimated at approximately \$20,000.

Surveillance was obtained which corroborated the information provided by Target Loss Prevention.

The Defendant is currently in custody and is pending three other felony matters in Hennepin County, where he is in violation of the terms of his conditional release.

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.


