Charge Description: That on or about December 16, 2021, in Hennepin County, Minnesota, Gordon Eugene Sharp Jr., either directly or as an accomplice, entered a building without consent and stole while in the building.



STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On December 16, 2021, Minneapolis Police officers were dispatched to a store located on the 1300 block of West Lake Street in Minneapolis, Hennepin County, Minnesota on the report of a theft. Officers responded and spoke with loss prevention staff who reported that GORDON EUGENE SHARP, JR, DEFENDANT herein, had just stolen an iPad from the store passing all points of purchase without paying for the merchandise before leaving the store. Loss prevention staff is familiar with Defendant as he has been caught stealing from the store on multiple occasions in the past few months and is currently trespassed from the store. The trespass notice was personally served on Defendant on August 18, 2021 and is valid for one year. This incident was captured on surveillance video.

Officers were able to locate Defendant in the area near the store and placed him under arrest for this offense. Defendant has three trespass burglary cases pending, as well as a theft of motor vehicle case.
