Charge Description: That on or about 12/17/2021, in Hennepin County, Minnesota, TERRELL JOHNSON unlawfully possessed one or more mixtures containing a Schedule I, II, III, or IV controlled substance, to-wit: methamphetamine.



STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On December 16, 2021, an officer made contact with TERRELL DANNIE JOHNSON, "the Defendant," in the Red Ramp at the Minneapolis-Saint Paul Airport, County of Hennepin, State of Minnesota. The officer had observed the Defendant at the another ramp previously. The officer believed the individual to have been trespassed from the airport. As the officer was speaking with the Defendant, the Defendant walked away and entered a hotel lobby where he sat in a chair and refused to leave. The Defendant was taken into custody and a search of his person revealed what later field tested positive as 0.8 grams of methamphetamine. The Defendant was additionally found to have a warrant out for his arrest.
