A <u>Probation Referral Handout Form</u> must also be given to the defendant if the defendant is to report to Probation in person.

Agreement on Sentence:

If the Court finds Ms. Greaves guilty of Count 1, the sentence would be:

- 27 months stayed for 3 years;
- 180 days jail (mandatory minimum);
- No contact with either victim (DANCO for Mr. Parker);
 - DANCO Exception: "Defendant permitted to contact third party for child visitation."
- PSI and follow recommendations;
- Restitution (if requested).

If the Court finds Ms. Greaves guilty of Count 2 and/or 3, the sentence for those counts would be:

- 15 months stayed for 3 years;
- 90 days jail;
- No contact with either victim (DANCO for Mr. Parker);
 - DANCO Exception: "Defendant permitted to contact third party for child visitation."
- PSI and follow recommendations;
- Restitution (if requested).

If the Court finds Ms. Greaves guilty of multiple counts, the sentences/jail time would be concurrent.
