**COMPLAINT**

Warrant

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I****Charge: Damage to Property - 1st Degree - Value Reduced Over \$1000**

Minnesota Statute: 609.595.1(4), with reference to: 609.595.1

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 02/25/2021

Control #(ICR#): 21039811

Charge Description: That on or about 2/25/2021, in Hennepin County, Minnesota, MARVAL BARNES intentionally caused damage to physical property belonging to Jerome's, without victim's consent and such damage reduced the value of the property by more than \$1,000 as measured by the cost of repair and/or replacement.

**COUNT II****Charge: Assault-5th Deg-Inflict or Attempt Bodily Harm**

**STATEMENT OF PROBABLE CAUSE**

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about February 25th, 2021, officers responded to a report of an assault at Red Rabbit, 201 Washington Avenue North, Minneapolis, Hennepin County, Minnesota. Victim P.B. indicated that he was paying his parking meter when a male assaulted him. P.B. had never seen the male before. P.D. had a cut on his left cheek.

As officers were speaking with P.B., victim S.J. stated that a male entered his store, Jeromeo's, at 250 3rd Avenue North, Minneapolis, Hennepin County, Minnesota and started breaking items. The male had destroyed at least \$5,000 worth of property. S.J. had a photo on his phone of the suspect.

Officers located a person matching the suspect description. P.B. identified Defendant as the person who assaulted him; S.J. identified Defendant as the person who damaged his property.

Defendant is currently in custody on another matter and has several open cases in Hennepin County. As such, your Complainant requests that this matter issue by warrant.

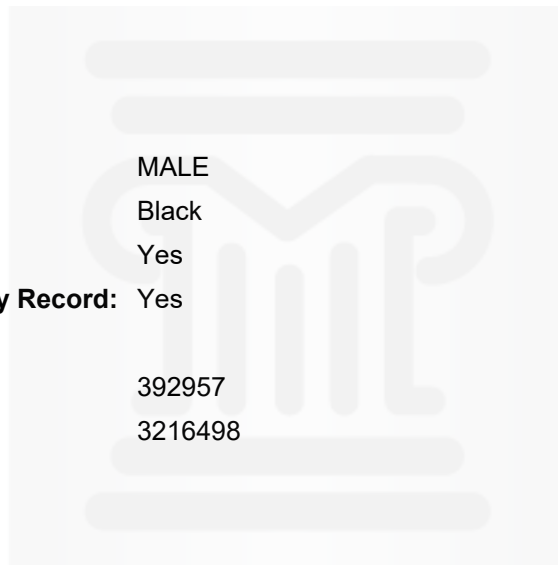
