The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 - Not Small Amount Marijuana

Charge Description: That on or about 10/9/2021, in Hennepin County, Minnesota, TERRELL JOHNSON unlawfully possessed one or more mixtures containing a Schedule I, II, III, or IV controlled substance, to-wit: methamphetamine.



STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about October 9, 2021, Bloomington Police was dispatched to a report of a male smoking an unknown substance near the eastern doors at the Mall of America in Bloomington, Hennepin County. Mall of America security advised law enforcement the male was currently trespassed.

The male was later identified as TERRELL DANNIE JOHNSON, DOB: 8/28/1979, Defendant herein. Officers observed a glass pipe with a small bag of a suspected narcotic situated near Defendant. Defendant claimed the substance was a vitamin. Defendant was advised he was trespassed and left the scene. The suspected narcotic field-tested positive for methamphetamine and weighed approximately 1.62 grams.

Defendant is currently in custody.
