COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I**Charge: INDECENT EXPOSURE/LEWDNESS OR PROCURE ANOTHER TO EXPOSE IN PRESENCE OF MINOR UNDER 16**

Minnesota Statute: 617.23.2(1)

Maximum Sentence: 0-1 year and/or \$0-\$3,000

Offense Level: Gross Misdemeanor

Offense Date (on or about): 07/05/2022

Control #(ICR#): 22005238

Charge Description: ... in any public place, or in any place where others were present, willfully and lewdly exposed his/her body, or the private parts thereof; or procured another to expose private parts; or engaged in any open or gross lewdness or lascivious behavior, or any public indecency; said conduct occurring in the presence of a minor under the age of 16 years;

COUNT II**Charge: INDECENT EXPOSURE-PUBLIC PLACE WILLFULLY/LEWDLY**

On or about July 5, 2022, at approximately 4:37 p.m., Metro Transit Real Time Information Center Operator K. Hendrickson heard dispatch indicate information about a male that had exposed himself and urinated at the Nicollet Mall Light Rail Station, in the city of Minneapolis, Hennepin County, Minnesota. The suspect was described as a white male with a grey scruff beard, between 50 and 60 years old, wearing a blue t-shirt, and blue jean cargo cutoff jean shorts. Hendrickson reviewed video of the incident, which was reported at approximately 4:25 p.m., and saw the male suspect, who was later positively identified as Mark Anthony Reinhart, the defendant herein, walk down the platform past a young toddler in a bright orange shirt, sit down on a bench just south where the toddler was waiting. The defendant then stood up, walk towards the middle of the platform, exposed himself and began urinating while the toddler was still present on the platform. Hendrickson tracked the defendant's movements on camera until he arrived at the East Lake Street Light Rail Station, where Hendrickson saw that he was taken into custody by Metro Transit Police. Metro Transit Police also spoke with the train operator, who indicated that, as he was pulling into the Nicollet Mall Station, he saw a white male with his penis fully out of his pants urinating on the platform and several customers who were standing near the suspect while he was urinating. The train operator also indicated that he could see that these customers appeared appalled by the male's behavior and some even appeared to be yelling at the male. The defendant was arrested and booked.

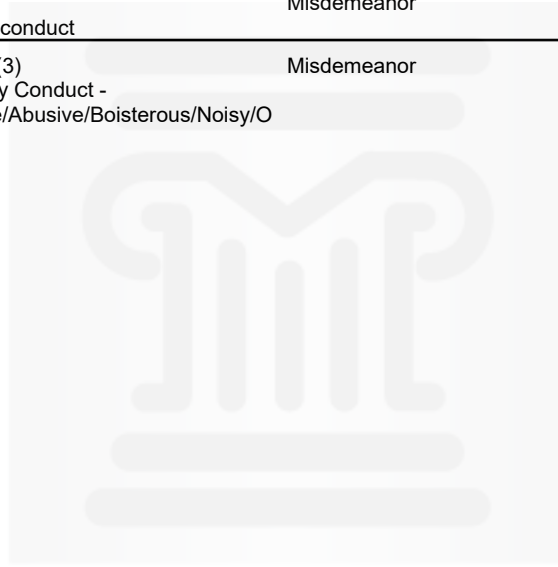
