TO THE ABOVE-NAMED COURT:

I wish to enter a plea of guilty in the above-entitled case, and I hereby state to the Court the following:

1. I am the Defendant in this case, my full name is Mark Anthony Reinhardt,
and my date of birth is 02/10/1962.
2. I am charged with Gross Mis. Trespass (23-2546); GMD Trespass (23-2439)
[name of offense(s)] and GMD Indecent Exposure (23-13185)
in violation of 609.605.1(b)8 and 617.23.2(1)
[statute(s) or ordinance(s)]
3. I hereby plead guilty to the offense(s) of MSD trespass (23-2546) and MSD
[name of offense(s)] indecent exposure (23-13185)
in violation of 609.605.1(b)(8) and 617.23.2(1)
[statute(s) or ordinance(s)]
4. I am pleading guilty because on 2/2/2023 in the City of Bloomington,
(date)
County of Hennepin, State of Minnesota, I committed the following acts (state sufficient facts to establish a factual basis for all elements of the offense(s) to which the defendant is pleading guilty): I was at the Mall of America in knowing violation of a trespass order from January 21, 2023. ON July 8, 2022 in Minneapolis, MN, Hennepin County, I urinated on the light rail platform, exposing a private part of my body to others.
5. I understand that the maximum possible sentence for any misdemeanor offense to which I am pleading guilty is 90 days imprisonment or a fine of \$ _____ or both, and that the maximum possible sentence for any gross misdemeanor offense to which I am pleading guilty is 364 days imprisonment or a fine of \$ _____ or both.

6. RIGHT TO AN ATTORNEY. I understand that I have the right to be represented by an attorney and that an attorney will be appointed to represent me without cost to me if I cannot afford to pay for an attorney.

8. I understand that I also have the following constitutional rights which I knowingly and voluntarily give up:

- a. The right to a trial to the court or to a jury in which I am presumed innocent until proven guilty beyond a reasonable doubt and in which all jurors in a jury trial must agree I am guilty before the jury could find me guilty.
- b. The right to confront and cross-examine all witnesses against me.
- c. The right to remain silent or to testify for myself.
- d. The right to subpoena and present witnesses to testify for me in my defense.
- e. The right to a pretrial hearing to contest the admissibility at trial of any confessions or admissions or of any evidence obtained from a search and seizure.

9. I am entering my plea of guilty freely and voluntarily and without any promises except as indicated in number 10 below.

10. I am entering my plea of guilty based on the following plea agreement with the prosecutor (if none, so state): Plead guilty to amended MSD trespass on case 23-2546, and Plead guilty to amended MSD indecent exposure (1017.23 Subd. 1(a)) on case 23-13185. Credit for time served on both charges. DISMISS CASE ending 23-2439

11. I understand that if the court does not approve this agreement I have the right to withdraw my plea of guilty and have a trial.

12. I understand that if this plea of guilty is accepted, I have the right to be present at the time of sentencing and to speak and to present evidence on my behalf.
