**COMPLAINT**

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I****Charge: Assault - 4th Degree - Peace Officer - Throws/transfers bodily fluids or feces at or onto officer**

Minnesota Statute: 609.2231.1(c)(2), with reference to: 609.101.2, 609.2231.1(c)

Maximum Sentence: 3 YEARS AND/OR \$6,000

Offense Level: Felony

Offense Date (on or about): 07/16/2022

Control #(ICR#): 22002419

Charge Description: That on or about 7/16/2022, in Hennepin County, Minnesota, TIA TIAUNNA PAYNE assaulted Victim 2, a peace officer, while that officer was effecting a lawful arrest or executing a duty imposed upon him by law, and intentionally threw or transferred bodily fluids or feces at or upon the officer.

**COUNT II****Charge: Assault-5th Degree-Fear of Bodily Harm or Death**

Minnesota Statute: 609.224.1(1), with reference to: 609.224.1, 609.101.2

Maximum Sentence: 90 DAYS AND/OR \$1,000

Offense Level: Misdemeanor

Offense Date (on or about): 07/16/2022

Control #(ICR#): 22002419

Charge Description: That on or about 7/16/2022, in Hennepin County, Minnesota, TIA TIAUNNA PAYNE committed an act with intent to cause fear in victim of immediate bodily harm or death.

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about July 16, 2022, at approximately 9:27 p.m., Richfield police officers were dispatched to 70XX 12th Avenue South, Richfield, Hennepin County, Minnesota, for a fight call. When officers arrived, they could hearing yelling coming from inside the residence. A female, later identified as TIA TIAUNNA PAYNE (dob: 12/19/1980) "Defendant" herein, was observed holding a large kitchen knife in her right hand.

Officers spoke with a juvenile male, "Victim" herein. Victim said a verbal argument began and Defendant grabbed Victim's PlayStation controller and threw it at a television breaking it. Defendant became angry and tried to hit Victim. Victim said Defendant grabbed his face and pulled his shirt. Victim went downstairs, then came upstairs but was prevented by Defendant from getting upstairs. Victim eventually went upstairs, and Defendant became angry and grabbed a kitchen knife and attempted to stab Victim. Victim said that during the altercation, Defendant said, "I'm going to kill you. I'm going to kill you."

Defendant was transported to the Hennepin County Adult Detention Center. While en route, Defendant was spitting in the back of the squad car. While in the back of the squad car, Defendant told an officer, "Victim 2" herein, she was going to spit on him. While at the jail, staff escorted Defendant into intake. As Defendant walked by Victim 2, she spit at Victim 2 and hit Victim 2 on the left arm.

Defendant is in custody.
