STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On 0805/2022 at approximately 2317 hours, the Minneapolis Police Department responded to the Home Depot located at 1520 New Brighton Blvd., Minneapolis, Hennepin County, Minnesota on a report of an active burglary/theft. The female suspect was known to loss prevention as BRITTANY LATESHIA (aka Latesha) CRUTCHFIELD, date of birth 03/06/1988 (DEFENDANT). [DEFENDANT has a pending felony burglary from this same store in 27-CR-21-23456.] DEFENDANT is currently trespassed from this Home Depot for multiple thefts. Loss prevention stated that DEFENDANT was placing items in a Cub Foods bag.

Law enforcement identified DEFENDANT in the store and was asked to place her hands behind her back. DEFENDANT took off running away from law enforcement. Law enforcement placed DEFENDANT under arrest after a lengthy struggle and active resistance.

Law enforcement found a narcotics pipe in DEFENDANT's pocket.

Home Depot reported that the total value of unpaid for items in DEFENDANT's possession was \$184.95.
