The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I**Charge: Aggravated Robbery-1st Degree**

Minnesota Statute: 609.245.1, with reference to: 609.245.1, 609.11.5(a), 609.05.1, 609.05.2

Maximum Sentence: 20 YEARS AND/OR \$35,000

Offense Level: Felony

Offense Date (on or about): 05/11/2022

Control #(ICR#): 22100129

Charge Description: That on or about May 11, 2022, in Hennepin County, Minnesota, NURADIN MOHAMUD, acting alone or intentionally aiding, advising, hiring, counseling or conspiring with another, took personal property from the person or in the presence of Victim, knowing that he was not entitled to the property and used and/or threatened the imminent use of force against Victim to overcome his resistance or powers of resistance to or to compel acquiescence in the taking or carrying away of the property, and inflicted bodily harm upon Victim.

Minimum Sentence: 3 YEARS

COUNT II**Charge: Aggravated Robbery-1st Degree**

Charge Description: That on or about May 11, 2022, in Hennepin County, Minnesota, MOHAMUD, acting alone or intentionally aiding, advising, hiring, counseling or conspiring with another, took personal property from the person or in the presence of Victim, knowing that he was not entitled to the property and used and/or threatened the imminent use of force against Victim to overcome his resistance or powers of resistance to or to compel acquiescence in the taking or carrying away of the property, while using an article used or fashioned in a manner to lead the victim to reasonably believe it to be a dangerous weapon (firearm).

Minimum Sentence: 3 YEARS

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about May 11, 2022, at approximately 2:45 a.m., Minneapolis Police officers were dispatched to an address on Portland Avenue, Minneapolis, Hennepin County, Minnesota, in regards to an armed robbery that had just taken place. Officers responded to the residence and spoke to a known adult male, Victim hereafter, who stated that an acquaintance known to him as "Cowboy" (later determined to be NURADIN MOHAMUD, Defendant hereafter), came to his residence along with two other males for an exchange of goods. Victim was seated in his apartment when suddenly one of the males struck Victim in the back of the head with a firearm. Victim heard a metallic sound and later discovered a single live round of ammunition inside of his apartment which he gave to the responding officers. Victim stated that he briefly lost consciousness and that the males ransacked his apartment and took, among other items, three watches valued at over \$500. Victim stated Defendant asked where the "black money bag" was while the three ransacked his apartment. Victim then yelled for help into the hallway and Defendant and the other two males fled the apartment.

Victim provided information regarding the CashApp transaction between Victim and Defendant that led to Defendant coming to Victim's residence. Officers obtained a search warrant for the account that Victim conducted the transaction with and learned that the account belonged to Defendant.

Officers executed a search warrant for surveillance video from Victim's residence and observed Victim allow three males, including one who appears to be Defendant, into the apartment's secured entrance. The same three males are later observed running from the secured entrance into a vehicle.

A lineup was conducted with Victim, who identified Defendant's photograph as "Cowboy."

Due to the serious nature of the offense, a warrant is requested.

The State hereby notifies Defendant of its intent to seek an aggravated departure from the sentencing guidelines pursuant to Minn. Stat. 244.10, subd. 5a(a)(10) and (14).

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.

Complainant declares under penalty of perjury that everything stated in this document is true and correct. Minn. Stat. § 358.116; Minn. R. Crim. P. 2.01, subds. 1, 2.
