STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On July 15, 2022, officers were dispatched to a residence located on the 5500 block of Boone Avenue North, City of New Hope in Hennepin County, Minnesota on report of an assault.

Officers arrived at the scene and obtained statements from multiple individuals. One of the individuals, a known minor female, Victim herein, provided officers with a recorded statement detailing the assault.

Victim told officers that she was involved in an altercation with multiple individuals after she observed her mother being assaulted by a known adult female identified as Jasmine Shree White. Victim attempted to intervene and while struggling with White, a known adult female and White's sister, CRYSTAL LATASHA MCBOUNDS, Defendant herein, approached Victim with a sword and swung it in her direction, striking Victim's head with a part of the sword.

At this time, Defendant is not in custody. Complainant is requesting a warrant be issued alongside this complaint.
