TREATMENT COURT

WHAT IS A TREATMENT COURT?

Treatment Courts supervise defendants who are residents of Hennepin County that have been placed on probation for a criminal offense, need mental health and/or substance use treatment, and who agree to have their probation supervised by the treatment court.

The goal of this program is to assist you in gaining the skills you need to meet your treatment and mental health goals and to benefit your overall quality of life.

All Treatment Courts include some type of TREATMENT to help you address problems in your life. Over the next year or more, a team will be there to HELP you set goals for your time in the program and create a treatment plan to help meet your needs. You may be asked to attend groups or programs to support your sobriety and recovery. You cannot use unprescribed drugs or alcohol while in a Treatment Court.

You will have regular court reviews or "check-ins" with the Judge and team to follow your progress and support you in the changes you are making. You will be asked to do regular drug and alcohol testing to keep you on track with staying clean and sober.

You deserve to succeed, and Treatment Courts are here to help!
