COMPLAINT

Warrant

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drugs - 3rd Degree - Sale - Narcotic

Minnesota Statute: 152.023.1(1), with reference to: 609.101.3, 152.023.3(a)

Maximum Sentence: 20 YEARS AND/OR \$75,000-\$250,000

Offense Level: Felony

Offense Date (on or about): 07/04/2021

Control #(ICR#): 21004642

Charge Description: That on or about 7/4/2021, in Hennepin County, Minnesota, Isaac Lee Kelley unlawfully sold, gave away, bartered, delivered, exchanged, distributed, disposed of to another, offered to sell, agreed to sell, manufactured or possessed with intent to sell one or more mixtures containing a narcotic drug, to wit: methamphetamine.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On July 4, 2021 at approximately 3:01 p.m., Metro Transit Police observed three males conducting a narcotics transaction at the Lake Street light rail stop in Minneapolis, Hennepin County. Officers observed two plastic bags containing a suspected narcotic on top of a black scale. One of the males grabbed the scale and one of the bags as officers approached.

The male was later identified as ISAAC LEE KELLEY, DOB: 3/7/1981, Defendant herein. During a search of Defendant's person, officers found another large bag containing a suspected narcotic in his pants. The suspected narcotic field-tested positive for methamphetamine and weighed approximately 20.068 grams.

Defendant is currently in custody.

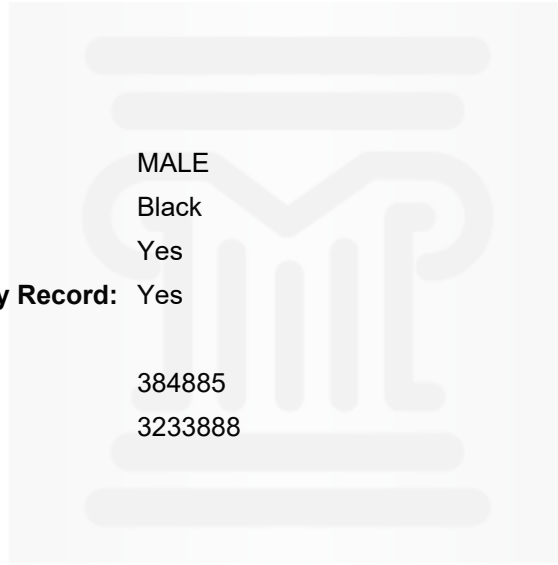
