### STATEMENT OF PROBABLE CAUSE

Your complainant is aware that over the course of three days July 17, 19 & 22nd of 2020, Defendant Michael Chantel Wright, Defendant herein violated a Harassment Restraining Order against K.J.B. victim herein and Defendants actions would reasonably be expected to cause K.J.B. emotional distress when Defendant continued to return to her property without permission.

That on July 17, 2020, at approximately 9:23 p.m., Officers Graupner and Barta responded to a call at a known address, located in the City of Minneapolis, Hennepin County, State of Minnesota. Officers spoke to the victim, who told them that Defendant was violating a Harassment Restraining Order (HRO) that she has against him. The victim told Officer Graupner that Defendant had come to her apartment building and been let in by neighbors. Victim saw the Defendant standing outside her door and called police. Defendant left before police arrived. Officer Graupner confirmed that the victim has an HRO against the Defendant. That HRO, 27-CV-18-20143, prohibits the Defendant from having any contact with the victim or being at her address. The HRO is effective until December 14, 2020. The Defendant has knowledge of the Order for Protection, as he was served with a copy of the Order for Protection on December 20, 2018, by Officer Herder.

That on July 19, 2020, at approximately 6:05 p.m., Officers Honican and Kuznetsov responded to a call at a known address, located in the City of Minneapolis, Hennepin County, State of Minnesota. Officers spoke to victim who told them Defendant was violating a Harassment Restraining Order (HRO) that she has against him. The victim told Officer Honican that Defendant was at the rear of her building in violation of the HRO. Officers went behind the building, located Defendant and placed him under arrest. Victim indicated that before calling police Defendant had knocked on her door and spoken to her through the door. Officer Honican confirmed that the victim has an HRO against the Defendant. That HRO, 27-CV-18-20143, prohibits the Defendant from having any contact with the victim or being at her address. The HRO is effective until December 14, 2020. The Defendant has knowledge of the Order for Protection, as he was served with a copy of the Order for Protection on December 20, 2018, by Officer Herder. That on July 22, 2020, at approximately 2:30 a.m., Officers Cape and Oachs responded to a call at a known address, located in the City of Minneapolis, Hennepin County, State of Minnesota. Officers spoke to victim who told them that Defendant was violating a Harassment Restraining Order (HRO) that she has against him. Upon arrival in the area Officers located Defendant sitting on the front steps of a home directly across the street from victim's home. Defendant was placed under arrest. Victim indicated that Defendant had rang the bell to her home then began shining flashlights in her windows from outside her home. Officer Cape confirmed that the victim has an HRO against the Defendant. That HRO, 27-CV-18-20143, prohibits the Defendant from having any contact with the victim or being at her address. The HRO is effective until December 14, 2020. The Defendant has knowledge of the Order for Protection, as he was served with a copy of the Order for Protection on December 20, 2018, by Officer Herder.

The State is requesting a warrant as Defendant has been on warrants status with the Court since October 25, 2022 after failing to appear at a hearing related to these charges.
