The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Assault-2nd Degree-Dangerous Weapon-Substantial Bodily Harm

Minnesota Statute: 609.222.2, with reference to: 609.222.2, 609.11.4, 609.101.2 Maximum Sentence: 10 YEARS AND/OR \$6,000-\$20,000 Offense Level: Felony

Offense Date (on or about): 06/12/2023

Control #(ICR#): 23005092

Charge Description: That on or about 6/12/2023, in Dayton, Hennepin County, Minnesota, ALEXANDER ORVAL THOMLEY, assaulted Victim and inflicted substantial bodily harm, while using a dangerous weapon.

Minimum Sentence: 1 YEAR AND 1 DAY

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On June 12, 2023, numerous police agencies responded to 1XXXX Stoneridge Circle in Dayton, Hennepin County, Minnesota, on a call of a domestic stabbing. An adult male, Victim herein, had called 911 and reported that his son, Alexander Orval Thomley (DOB 11/9/96), Defendant herein, had stabbed him multiple times.

Upon arrival officers found Victim sitting in his truck at the end of his driveway. Officers removed Victim from the truck and began providing medical aid. Officers observed Victim to have six total stab wounds. Four wounds measured ½ to 1 inch in length and were near his spine in his middle to upper right back, and two additional wounds measured ½ inch long and were to his right shoulder/shoulder blade. Officers observed that the largest wound was gurgling with air. Victim was in a great deal of pain and had difficulty speaking, but identified his son, Defendant, as being involved and provided Defendant's phone number. Victim was transported to North Memorial Hospital.

While at the hospital, Victim told officers that Defendant stabbed him with a 6" kitchen knife after having a "mental breakdown." He further stated Defendant was last seen entering the residence.

Officers provided Defendant's phone number to negotiators on scene, who made several unsuccessful attempts to contact Defendant and have him exit the residence. Officers eventually obtained a search warrant and entered the residence. Defendant was located inside and taken into custody.

While in the residence officers observed signs of a struggle in an upper-level bedroom where a large screen tv was broken on the floor. They further observed a trail of blood from the bedroom toward the staircase leading to the main level. Officers also recovered a kitchen knife with what appeared to be dried blood on it from a basement bedroom believed to belong to Defendant.

Defendant is in custody.


