The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Use Tear Gas to Immobilize - Not Protect Self/Property

Minnesota Statute: 624.731.4(d), with reference to: 624.731.8(a)(4), 609.03.1 Maximum Sentence: 5 YEARS AND/OR \$10,000 Offense Level: Felony

Offense Date (on or about): 04/21/2023

Charge Description: That on or about 4/21/2023, in Hennepin County, Minnesota, INGRAM METEBO OYUGI used tear gas or a tear gas compound in an immobilizing concentration against another person.

COUNT II

Charge: Assault - 4th Degree - Peace Officer - Demonstrable bodily harm

Minnesota Statute: 609.2231.1(c)(1), with reference to: 609.101.2, 609.2231.1(c) Maximum Sentence: 3 YEARS AND/OR \$6,000 Offense Level: Felony

Charge Description: That on or about 4/21/2023, in Hennepin County, Minnesota, INGRAM METEBO OYUGI assaulted (Victim), a peace officer, while that officer was effecting a lawful arrest or executing a duty imposed upon him by law, and inflicted demonstrable bodily harm upon the officer.

COUNT III

Charge: Use Tear Gas/Stun Gun on a Peace Officer

Minnesota Statute: 624.731.4(a), with reference to: 624.731.8(b)(1) Maximum Sentence: 1 YEAR AND/OR \$3,000 Offense Level: Gross Misdemeanor

Offense Date (on or about): 04/21/2023

Charge Description: That on or about 4/21/2023, in Hennepin County, Minnesota, INGRAM METEBO OYUGI, knowingly, or with reason to know, used a tear gas compound, an authorized tear gas compound, or an electronic incapacitation device on or against a peace officer who was in the performance of duties.



MINNESOTA JUDICIAL BRANCH

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about April 21, 2023, Brooklyn Park police officers were called to help with the service of an Order for Protection (OFP) (27-DA-FA-23-2240) at 19XX Teton Trail, Brooklyn Park, Hennepin County, Minnesota against INGRAM METEBO OYUGI (DOB:08/31/1991) "Defendant" herein. The OFP prevented Defendant from residing at the residence. Defendant also had an active warrant (27-CR-23-8342). Officers made contact with Defendant over the phone and attempted to get Defendant to peacefully exit the house. Defendant refused to exit the home.

Eventually, officers entered the home and could hear defendant yelling from downstairs in the basement area that he was not going to come out. Officers advised him multiple times of the order requiring him to come out of the residence. Defendant then began to spray an aerosol substance up the stairwell from the basement to the living room area. Officer had to utilize gas masks to prevent from being contaminated by the spray. While at the scene officer observed a red laser flash up the stairway and two taser probes get launched from the basement toward officers. One officer war was struck but not injured. Officers attempted to negotiate with defendant for several hours. At one point the defendant began walking around the basement with a large metal baseball bat. He walked up the stairs with the bat in a manner consistent with using it to potentially swing at the officers. The defendant was eventually detained and began spitting at officers.

Officers collected evidence from the scene, including a hand-held taser device, a can of bear mace, and the baseball bat.

Defendant is in custody.
