COMPLAINT

Warrant

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I**Charge: Terroristic Threats-Reckless Disregard Risk**

Minnesota Statute: 609.713.1, with reference to: 609.713.1

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 06/27/2018

Control #(ICR#): 18212959

Charge Description: That on or about June 27, 2018, in Hennepin County, Minnesota, IFRAH ABDULL HASSAN did threaten to commit a crime of violence with the purpose of terrorizing Victim, S.M., or in reckless disregard of the risk of causing terror in Victim.

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On June 27, 2018, Minneapolis Police Department officers responded to the intersection of Chicago Avenue South and Franklin Avenue East in Minneapolis, Hennepin County, Minnesota, to investigate a report of a woman asking the caller for money and threatening her with a weapon. Moments before police arrived, two Minnesota Department of Corrections agents, who also heard the report, detained Defendant, IFRAH ABDULL HASSAN. Defendant matched the description provided by the 911 caller. Police searched Defendant and found a paring knife inside a plastic bag she was carrying.

Police spoke to Victim S.M., who said that she drove into a nearby parking lot. Defendant approached Victim's car and asked her for money. Victim refused to give Defendant money and rolled up her window. Defendant displayed a knife, made an overhead downward stabbing motion toward Victim, and yelled "I'm going to kill you bitch" and "bitch get out of the car!" Victim was scared, so she stayed in her vehicle and called 911.

Police also spoke to Witness, an employee at a nearby restaurant. Witness told police that Defendant was asking customers for money inside the restaurant, became angry with someone, and pulled a knife. He said the restaurant manager told Defendant to leave and Witness helped escort Defendant out of the restaurant.

The State is seeking a warrant for Defendant's arrest, because Defendant's whereabouts are unknown and she poses a risk to public safety.
