The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: TRESPASS-RETURN TO PROPERTY WITHIN ONE YEAR

STATEMENT OF PROBABLE CAUSE

That on October 17, 2018 at approximately 9:29 a.m., Officer Atkins was on routine patrol in the area of Hennepin Avenue and Lyndale Avenue in the City of Minneapolis, County of Hennepin, State of Minnesota, when he a male who he recognized as, WILLIAM LEE NABORS, Defendant herein, sitting on a drainage structure on the hillside. Officer Atkins had previously issued a trespass notice to the Defendant on October 2, 2018 after reading him a prepared script. That trespass notice is in effect until October 2, 2019 and prohibits the Defendant from returning to the area of Hennepin Avenue South and Lyndale Avenue South during that time period.

Hennepin County Court records indicate that on May 26, 2015, in MNCIS court case #27-CR-15-13910, Defendant pled guilty to trespass occurring on May 21, 2015, pursuant to Minn. Stat. § 609.605, and that on June 22, 2015, in MNCIS case #62SU-CR-15-1426, Defendant pled guilty to trespass occurring on May 1, 2015, pursuant to Minn. Stat. § 609.605.
