COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 - Not Small Amount Marijuana

Minnesota Statute: 152.025.2(1), with reference to: 609.101.3, 152.025.4(b)

Maximum Sentence: 5 YEARS AND/OR \$3,000-\$10,000

Offense Level: Felony

Offense Date (on or about): 11/02/2020

Control #(ICR#): 20010398

Charge Description: That on or about 11/2/2020, in Hennepin County, Minnesota, CASPER HUY VUONG unlawfully possessed one or more mixtures containing a Schedule I, II, III, or IV controlled substance, to-wit: methamphetamine.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On November 2, 2020 Robbinsdale Police Officers were on routine patrol and were pulling out of the Hy-Vee grocery store parking lot located at 36th Avenue North in the city of Robbinsdale, Hennepin County, State of Minnesota.

While exiting the parking lot officers observed a known suspect walking towards the store who was known to have an active trespass from the store as well as warrants. The suspect was CASPER HUY VUONG (3/21/1985), hereinafter referred to as Defendant.

Officers approached Defendant, confirmed his identity, and advised him of his active warrants. Defendant was placed under arrest. Incident to arrest officers discovered a baggie which contained a white crystalline substance.

The substance field tested positive for methamphetamine and weighed .22 gram without packaging. Defendant has a prior controlled substance conviction in case 02-CR-20-802.

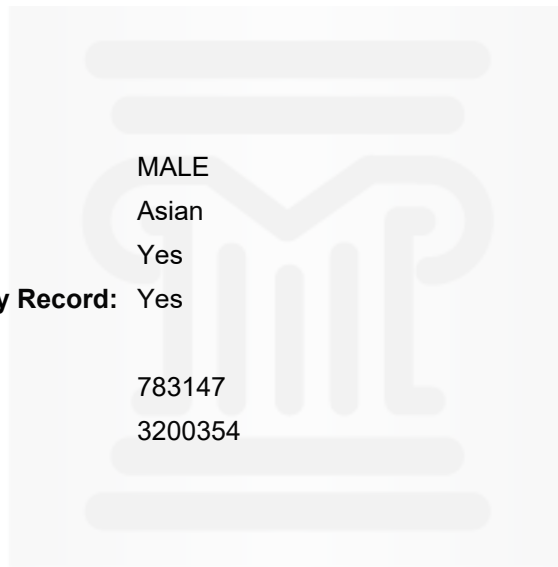

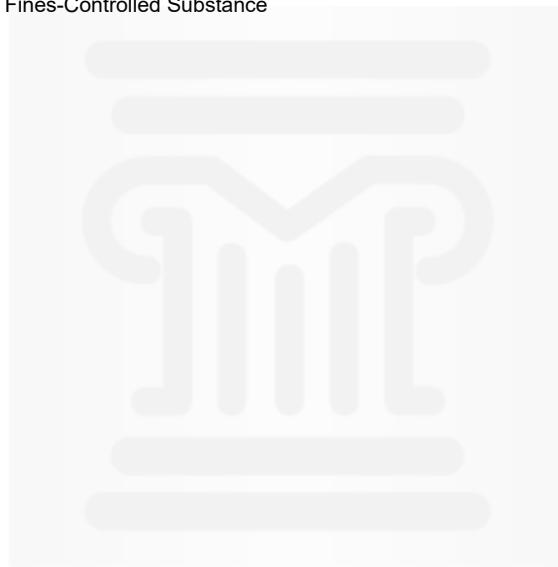
