COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Burglary-3rd Deg-Steal/Commit Felony or Gross Misd

Minnesota Statute: 609.582.3, with reference to: 609.582.3

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 10/01/2021

Control #(ICR#): 21225426

Charge Description: That on or about 10/1/2021, in Hennepin County, Minnesota, GORDON EUGENE SHARP, either directly or as an accomplice, entered a building without consent and with intent to steal or commit any felony or gross misdemeanor while in the building, or entered a building without consent and stole or committed a felony or gross misdemeanor while in the building.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On October 1, 2021 at approximately 12:35 p.m., Minneapolis Police was dispatched to a reported theft in a Target situated on Lake Street in Minneapolis, Hennepin County. The reporting party, a Target employee, noted a known suspect stole several packages of socks and underwear. The suspect made no attempt to pay for the items and walked past all points of sale. The suspect was later identified as GORDON EUGENE SHARP, DOB: 5/13/1988, Defendant herein. Defendant was previously trespassed from the store on August 18, 2021.

On October 26, 2021, law enforcement observed Defendant in the aforementioned Target store. Defendant was arrested and transported to the Hennepin County Jail. The store has documented Defendant's 46 thefts in the store between June 15, 2021 and October 9, 2021.

Defendant is currently in custody.
