COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I**Charge: Simple Robbery**

Minnesota Statute: 609.24, with reference to: 609.24

Maximum Sentence: 10 YEARS AND/OR \$20,000

Offense Level: Felony

Offense Date (on or about): 01/13/2021

Control #(ICR#): 21008655

Charge Description: That on or about January 13, 2021, in Hennepin County, Minnesota, DWAYNE ANTHONY BLEDSOE took personal property, from the person knowing that he was not entitled to the property and used and/or threatened the imminent use of force against the victim to overcome his/her resistance or powers of resistance to or to compel acquiescence in the taking or carrying away of the property.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On January 13, 2021, at approximately 11:00 a.m., Minneapolis Police Officers responded to an apartment in the 4600 block of Lyndale Avenue N, City of Minneapolis, Hennepin County, Minnesota on a report of a Domestic Abuse No Contact Order Violation.

Officers arrived and spoke with Victim, a known adult female. Victim said she returned home from the hospital around 9:00 a.m. and saw her ex-boyfriend, Dwayne Anthony Bledsoe, (D.O.B. 11-3-1979), Defendant herein.

Defendant pointed an object with a laser light at Victim and said something like "I told you I was going to kill you." Defendant then told Victim to drop the charges against him. There is a pending DANCO case involving these parties in 27-CR-20-7092 with a court date on January 14, 2021. Victim ran toward her apartment. Defendant reached toward Victim, yanking her coat off her body. Defendant then grabbed Victim's hand and pulled her cell phone out of it.

Defendant was later arrested after calling law enforcement to get help gaining access to Victim's building to retrieve his belongs.

Defendant was convicted of misdemeanor Domestic Assault on October 8, 2019 in 27-CR-19-22754. A DANCO was issued in this file but expired on October 8, 2020.

Defendant is in custody.

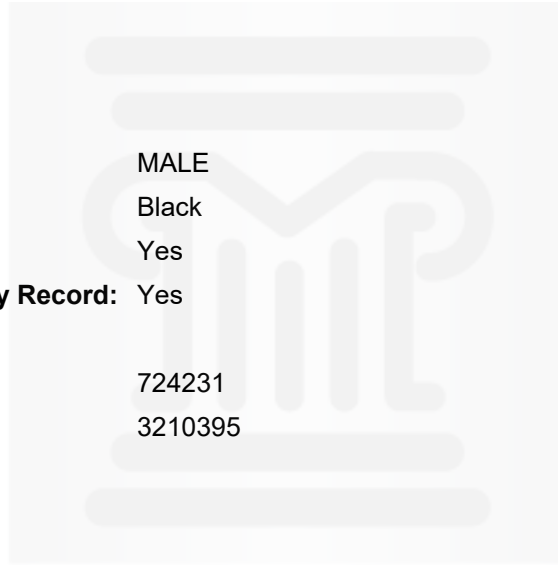
