COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I**Charge: Burglary-2nd Degree-Dwelling**

Charge: Burglary-2nd Degree-Dwelling

Charge Description: That on or about 8/2/2022 through 10/9/2022, in Hennepin County, Minnesota, Dennis Joseph Barry, either directly or as an accomplice, entered a dwelling without consent, and with intent to commit a crime or committed a crime, while in the building.

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about August 23, 2022, a St. Louis Park police officer was dispatched to meet with an apartment property manager at 13XX Utica Avenue, St. Louis Park, Hennepin County, for a burglary report. The manager said on multiple occasions one or two suspects entered the apartment garage and stole bikes belonging to tenants. Information for the case was sent to CISA who identified one of the males as Dennis Joseph Barry, (DOB: 05/14/1977) "Defendant" herein. An investigator was assigned, and reviewed video footage related to multiple thefts in the St. Louis Park area.

On August 2, 2022, surveillance video footage shows defendant at an apartment complex at 13XX Utica Avenue South, St. Louis Park. Defendant can be observed using a tool similar to a wire cutter to cut the lock to a blue mountain bike. Defendant leaves the apartment with the mountain bike and a pair of hunting boots belonging to a resident. The boots are approximately \$170.

On August 14, 2022, surveillance video footage shows Defendant entering a secured apartment complex at 49XX Cedar Lake Road, St. Louis Park. Defendant can be seen using tools to gain access to a locked front door and then leaves the garage with a \$900 Trek bike. Defendant is wearing a yellow mustard shirt, a green baseball hat, and blue backpack.

On August 15, 2022, surveillance video footage shows defendant in a secured apartment complex at 13XX Utica Avenue South, St. Louis Park. Defendant is wearing the same yellow shirt, green baseball hat, and blue backpack. Defendant cuts a lock off of a red Specialized bike.

On August 17, 2022, surveillance video footage shows Defendant and another male enter a secured apartment complex at 13XX Utica Avenue South, St. Louis Park. Defendant is observed using a long silver hook to manipulate the door to gain access to the apartment complex. Defendant is wearing the same shirt, baseball hat, backpack, and pants from the Aug. 17, 2022, incident. Defendant can be seen using a cordless saw to cut a bike lock on two bikes. Defendant and the other male take two bikes, a mint green Specialized worth \$913.95 and a mountain bike worth \$779.99.

On September 2, 2022, Defendant was stopped by Minnesota State Patrol and in possession of a stolen bike. Defendant was wearing a camo cap. The trooper confirmed that the defendant was the same person seen in the apartment surveillance video footage.

On Oct. 5, 2022, surveillance video footage shows defendant in a secured apartment complex at 13XX Utica Avenue South, St. Louis Park. The video shows defendant holding a long silver hook tool. He enters the garage and exits with two bicycles. A black mountain bike with a yellow base near the seat and a tan Raleigh mountain bike, which is priced at \$650. Defendant is wearing a camo winter coat and the same camo cap from September 2, 2022.

On October 9, 2022, surveillance video footage shows Defendant in a secured apartment complex at 13XX Utica Avenue South, St. Louis Park. Video shows defendant use a long silver hook tool to manipulate the handle though a gate to gain access to the apartment complex. He steals a red Trek bike worth \$1,500 and a bike rack extension.

On November 8, 2022, Defendant was arrested wearing the same camo winter coat from the October 5, 2022, burglary. Defendant was also wearing a backpack. Inside the backpack were multiple flashlights, a

portable cordless saw, a black crowbar, and a long silver hook type tool that was seen in multiple burglary videos.

The criminal investigation is ongoing along with the possibility of additional charges.

Defendant is in custody.

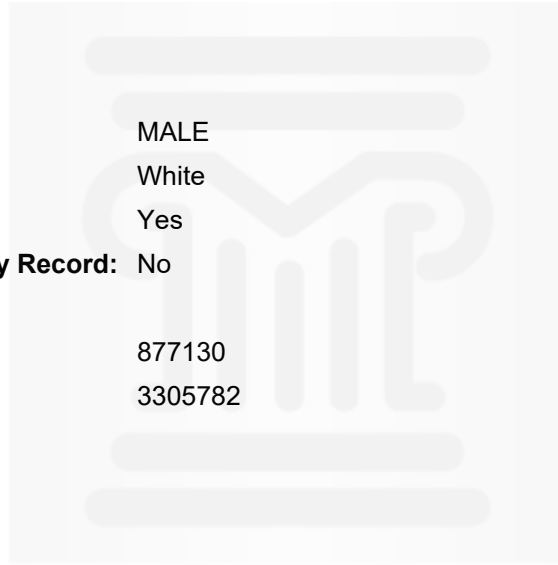
