COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 - Not Small Amount Marijuana

Minnesota Statute: 152.025.2(1), with reference to: 609.101.3, 152.025.4(b)

Maximum Sentence: 5 YEARS AND/OR \$3,000-\$10,000

Offense Level: Felony

Offense Date (on or about): 03/15/2022

Control #(ICR#): 22003111

Charge Description: That on or about 3/15/2022, in Hennepin County, Minnesota, TERRELL JOHNSON unlawfully possessed one or more mixtures containing a Schedule I, II, III, or IV controlled substance, to-wit: methamphetamine.

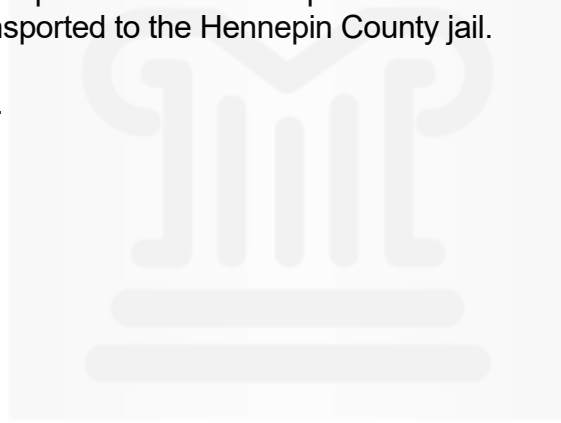
STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On March 15, 2022, at approximately 9:15 a.m., Hennepin County Sheriff's deputies were dispatched to the 8th floor of the Hennepin County Government Center in Minneapolis, Hennepin County. Dispatch advised a black male wearing a red and black jacket was being disorderly on the floor.

The male was later identified as TERRELL DANNIE JOHNSON, DOB: 8/28/1979, Defendant herein. Defendant was trespassed from the building on November 17, 2021, and he had an active misdemeanor warrant out of Scott County. Deputies found a suspected narcotic during a search of Defendant's person; the suspected narcotic field-tested positive for methamphetamine and weighed approximately 1.24 grams. Defendant was arrested and transported to the Hennepin County jail.

Defendant is currently in custody.

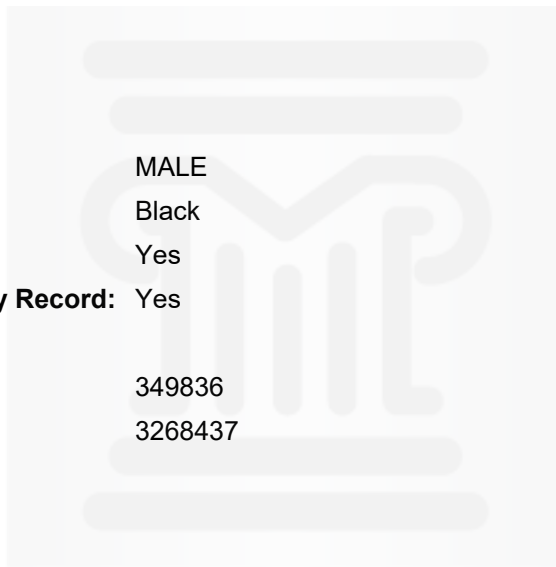
