COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I**Charge: Threats of Violence - Reckless Disregard Risk**

Minnesota Statute: 609.713.1, with reference to: 609.713.1, 609.11.4

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 08/02/2023

Control #(ICR#): 23005243

Charge Description: That on or about August 2, 2023, in Hennepin County, Minnesota, Fue Vang did threaten to commit a crime of violence with the purpose of terrorizing another, and/or in reckless disregard of the risk of causing terror in another, Victim, using a dangerous weapon, to wit his hands.

Minimum Sentence: 1 YEAR AND 1 DAY

COUNT II**Charge: Domestic Assault - By Strangulation**

Maximum Sentence: 3 YEARS AND/OR \$5,000

Offense Level: Felony

Offense Date (on or about): 08/02/2023

Charge Description: That on or about August 2, 2023, in Hennepin County, Minnesota, Fue Vang assaulted Victim, a family member, by strangulation.

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about 5:49 a.m. on 8/02/2023, Fue Vang, herein Defendant, chased Victim, his mother, as she fled from him, knocked her to the ground and strangled her from behind using both hands while threatening to kill her. Victim struggled to breathe and was in fear for her life. Defendant was mad because he believes Victim took his cigarettes. When Officer advised Defendant that he was under arrest, Defendant asked, "Why?" Officer stated because he choked his mom. Defendant spontaneously stated, "Yeah because she took my cigarettes."

This incident took place at their home at 21XXX Horseshoe Trail, Corcoran, Hennepin County, Minnesota.

Defendant is currently in custody.

Defendant has a 05/25/2022 warrant in open Anoka County case 02-CR-21-5729, 1st Degree Arson.

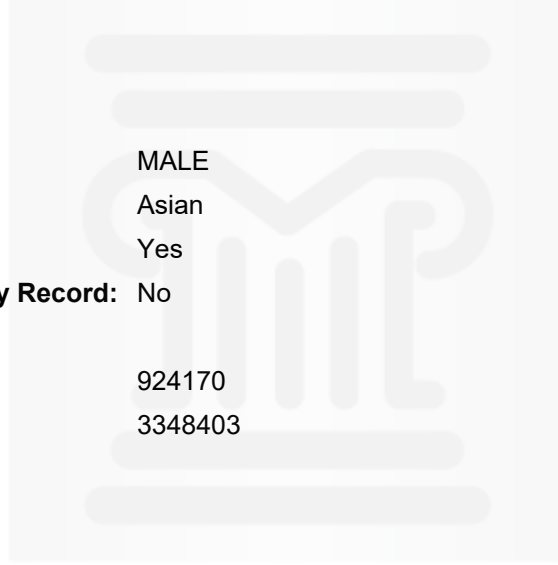
