COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I**Charge: Assault-2nd Degree-Dangerous Weapon**

Minnesota Statute: 609.222.1, with reference to: 609.222.1, 609.101.2

Maximum Sentence: 7 YEARS AND/OR \$4,200-\$14,000

Offense Level: Felony

Offense Date (on or about): 02/11/2023

Control #(ICR#): 23034491

Charge Description: That on or about 2/11/2023, at 3050 1st Ave S in Minneapolis in Hennepin County, Minnesota, MUAD ABDULKADIR, assaulted victim, while pointing a handgun.

COUNT II**Charge: Threats of Violence - Reckless Disregard Risk**

Minnesota Statute: 609.713.1, with reference to: 609.713.1

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 02/11/2023

Control #(ICR#): 23034491

Charge Description: That on or about 2/11/2023, at 3050 1st Ave S in Minneapolis in Hennepin County, Minnesota, MUAD ABDULKADIR did threaten to commit a crime of violence with the purpose of terrorizing another, and/or in reckless disregard of the risk of causing terror in another, victim.

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On 2/12/2023 at approximately 22:40 hours, officers were dispatched to 3050 1st Ave S in Minneapolis for a person with a gun at a business. The suspect was described as a Somali male with a red scarf and black clothing. When officers arrived on scene, bystanders began to point at a male matching that description.

The male was placed in handcuffs without incident and told he was under arrest and identified as MUAD ABDULKADIR DOB: 1/1/1994 (now referred to as DEFENDANT).

Multiple witnesses stated the DEFENDANT was observed harassing customers and asked to leave. At that time the DEFENDANT became hostile and pulled out a handgun and pointed it at several people, telling them he was going to kill them.

A handgun was found in DEFENDANT's outer clothing and entered into evidence.

Bloomington police were notified because they had previously entered a KOPS alert for the suspect about an hour earlier after he committed a robbery in their city.

DEFENDANT is currently in custody at the Hennepin County Jail.
