COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Assault-2nd Degree-Dangerous Weapon

Minnesota Statute: 609.222.1, with reference to: 609.222.1, 609.11.4, 609.101.2, 609.11.9

Maximum Sentence: 7 YEARS AND/OR \$4,200-\$14,000

Offense Level: Felony

Offense Date (on or about): 04/02/2020

Control #(ICR#): 20086696

Charge Description: That on or about 4/2/2020, in Minneapolis, Hennepin County, Minnesota, BISHARO JAMA NOOR, assaulted N.C.K. while using a dangerous weapon.

Minimum Sentence: 1 YEAR AND 1 DAY

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On April 2, 2020, law enforcement responded to an assault at 1912 Stevens Avenue South, Minneapolis, Hennepin County, Minnesota. At the scene, law enforcement observed significant injuries to N.C.K., adult female. Specifically, law enforcement observed deep wounds to her head area and large amounts of blood.

N.C.K. stated she was attacked by BISHARO JAMA NOOR, DOB: 01/01/1988, Defendant herein. During the attack, Defendant used a piece of wood with nails in it. Defendant was arrested just down the block from the assault and N.C.K. confirmed law enforcement arrested the correct person.

Law enforcement also located the piece of wood in the area where the assault took place.
