COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I**Charge: Theft-Take/Drive Motor Vehicle-No Owner Consent**

Minnesota Statute: 609.52.2(a)(17), with reference to: 609.52.3(3)(d)(v)

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 01/27/2021

Control #(ICR#): 21000834

Charge Description: That on or about 1/27/2021, in Hennepin County, Minnesota, GORDON EUGENE SHARP took and/or drove a motor vehicle, a blue Honda Civic, without the consent of JMB or the owner's authorized agent, and he/she knew or had reason to know that the owner or authorized agent did not give consent, and the motor vehicle had a value of less than One Thousand Dollars (\$1,000.00) and the property stolen is a motor vehicle.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about January 27, 2021 police offices were dispatched to the Indigo Apartments, Bloomington, Hennepin County, Minnesota on reports of a motor vehicle theft. VICTIM reported a family member went outside to start the car to warm it up, VICTIM heard the engine revving and the vehicle took off down 80 1/2th Street towards 33rd Ave. VICTIM's family member attempted pursuit but lost the vehicle on 33rd Ave. Vehicle was identified as a blue Honda civic with a black hood, Minnesota plates 697XLR.

That same day police officers observed the vehicle Minnesota plates 697XLR at a traffic light near the intersection of 98th Street and 35W, Bloomington. Officers performed a traffic stop the driver and sole occupant was identified as GORDON EUGENE SHARP DOB 05/13/1988 ("DEFENDANT").


