COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I**Charge: Burglary-3rd Deg-Steal/Commit Felony or Gross Misd**

Minnesota Statute: 609.582.3, with reference to: 609.582.3

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 12/19/2021

Charge Description: That on or about 12/19/2021, in Hennepin County, Minnesota, BRITTANY LATESHA CRUTCHFIELD, either directly or as an accomplice, entered a building without consent and with intent to steal or commit any felony or gross misdemeanor while in the building, or entered a building without consent and stole or committed a felony or gross misdemeanor while in the building.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On 12/19/2021, law enforcement officers with the Minneapolis Police Department were notified of a trespassed party that stole from the Home Depot located at 1520 New Brighton Blvd, Minneapolis, Hennepin County. The individual was subsequently identified as BRITTANY LATESHIA CRUTCHFIELD, date of birth 03/06/1988 (DEFENDANT).

A Home Depot employee notified law enforcement as DEFENDANT had been caught stealing multiple times. Law enforcement observed DEFENDANT leaving the store with a grocery bag without attempting to pay for any items. Inside the bag, law enforcement found a Dewalt drill valued at \$149.00.

DEFENDANT was trespassed on 11/21/2021 and has other theft incidents on 11/22/2021, 11/26/2021, and 12/06/2021.

BAIL IS RECOMMENDED DUE TO THE CHARGE AND REPEATED OCCURENCES.

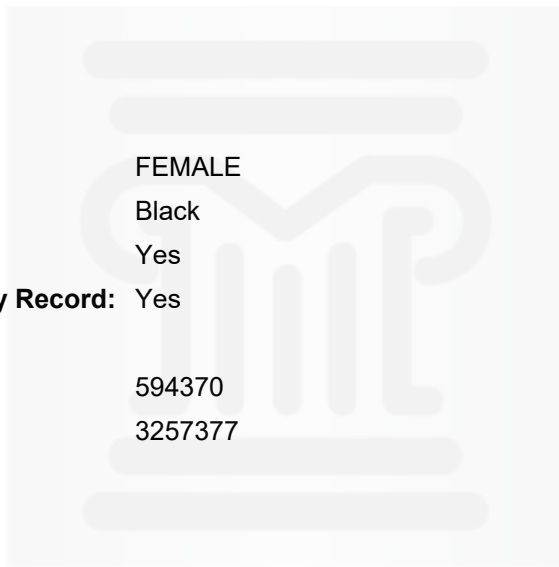
