COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I**Charge: Theft-Take/Use/Transfer Movable Prop-No Consent**

Minnesota Statute: 609.52.2(a)(1), with reference to: 609.52.3(d)(i)

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 08/22/2023

Control #(ICR#): 23224620

Charge Description: That on or about August 22, 2023, in the city of Minneapolis, in Hennepin County, Minnesota, RICKY NELSON SULLIVAN, JR., intentionally and without claim of right, took, used, transferred, concealed or retained possession of movable property belonging to (victim) without consent and with the intent to deprive the owner/entity permanently of possession of the property, and the property was taken from the person of another.

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On August 22, 2023, officers with the Minneapolis Police Department responded to a business robbery located at 150 5th Street South in the city of Minneapolis, Hennepin County, Minnesota.

Upon arriving, the officer spoke with the store clerk, Victim herein, who stated that an adult male, later identified as RICKY NELSON SULLIVAN, JR., DOB: 04/19/1987, Defendant herein, walked behind the counter and told Victim "Give me the money." Victim opened the cash register, and Defendant shoved her out of the way. Defendant took approximately \$454.00 from the register and left the store.

On August 27, 2023, Defendant returned to the store. A different cashier was working that day. Defendant approached the counter and stated, "Give me the money." Defendant took \$1,158.00 from the register.

Defendant was identified by at least two people familiar with Defendant. It was explained that Defendant frequents the area, and he had previously stolen food from the business on prior occasions.

Defendant is in custody.

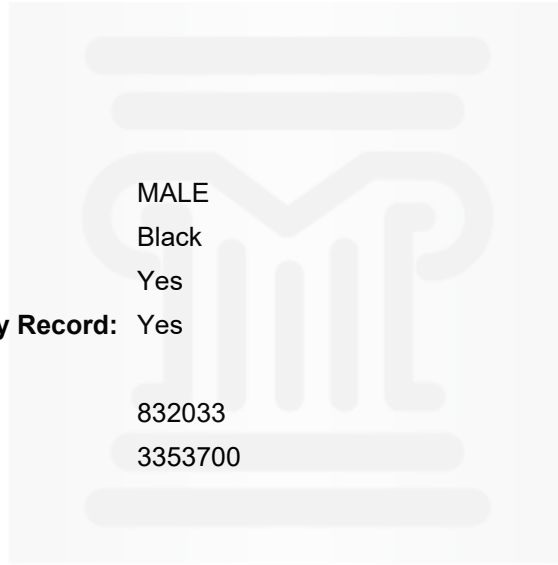
